THIS INDENTURE, made this 19 day of July, A.D. 1972 between John J. Twomey, United States Marshal for the Northern District of Illinois, party of the first part and the Department of Housing and Urban Development, for and on behalf of the United States of America, party of the second part, WITNESSETH:

WHEREAS, in pursuance of a decree entered on the 7th day of August, 1972, by the United States District Court for the Northern District of Illinois, in a certain cause then pending therein, wherein the United States of America, was plaintiff and Zion Temple Towers Corporation, was defendant, Civil No. 71 C 2733, the said Marshal duly advertised according to law the premises hereinafter described for sale at public auction to the highest and best bidder for cash at the hour of 2:00 p.m. in the afternoon on October 27, 1972, at Room 704 of the Chicago Civic Center, in the City of Chicago, County of Cook, Illinois.

AND WHEREAS, at the time and place aforesaid appointed for said sale, the United States Marshal attended to make the same, and offered and exposed said premises for sale at public auction to the highest and best bidder for cash, and thereupon the Department of Housing and Urban Development offered and bid therefor the sum of TWO HUNDRED SEVENTY FIVE THOUSAND SEVEN HUNDRED and 00/100 (\$275,700.00) dollars; this sum being the highest and best bid offered, said Marshal accordingly struck off and sold to said plaintiff, for the sum of money, the said premises and did thereupon sign and deliver the usual Marshal's Certificate of Sale to the Department of Housing and Urban Development, for and on behalf of the United States of America.


