LOT SIXTY NINE (69), BLOCK THIRTY SEVEN (37), SECTION THIRTY FIVE (35)

to have and to hold the above described premises, as a place of interment, to the said grantees their heirs and assigns forever; subject, however, to the conditions and limitations, and with the privileges and restrictions specified in the Rules and Regulations of OAKRIDGE CEMETERY, now in force, or that may hereafter be adopted by it, which Rules and Regulations are hereby specifically made a part of this conveyance.

The net income from such Trust Fund, and from such addition, as may be made to it from time to time shall be used for the benefit of all lots and purposes for which the same has been deposited and the proportionate share thereof applicable to the deposit made under this agreement shall be expended for the care, maintenance and in such proportion and in such manner as the Cemetery, Corporation, in its sole discretion, shall determine, for any one or more of the following: Cutting the grass, raking and removing leaf and keeping them in good repair; caring for and maintaining the foundation of any monuments and headstones; insurance coverage of all lots; insurance weights and fees; ownership and burial records; and the erection, purchase, maintenance, improvement and replacement of all cemetery buildings, driveways, drainage and water system, fences, shrubbery, trees, equipment, fixtures, improvements and any and all other appurtenances and uses as are for the use or benefit of such lots.
