Lot eighty-one (81) in Glenbrook Estates, being a Subdivision of that part of the North East Quarter of the South East Quarter (excepting the West 75 feet of the North 500.80 feet thereof) of Section 29, Township 42 North, Range 12, East of the Third Principal Meridian, lying South and West of the land acquired for the realignment of Lake Avenue and Pfingson Road by the Condemnation Case 62-6274, Tract 20 filed April 26, 1962 in Cook County, Illinois.


