In case of detailed inquiry it will be the burden of the party to establish the right of the corporation to make such a claim. The corporation may be compelled to prove its right to sue in the name of the state, and to show that it has been injured by the conduct of the party sued.

Where no such charge is made, the lessee may increase his rent to cover the amount of the additional expenses, if he can do so without increasing his liability for damages or for breach of lease, and without incurring a forfeiture.
