THIS INDENTURE, made this 15th day of September, 1972, between WESTERN NATIONAL BANK OF CICERO, a Corporation, operating under the laws of the United States of America, as Trustee under the provisions of a deed or deeds in trust, duly recorded and delivered to said bank in pursuance of a trust agreement dated the 2nd day of November, 1972, and known as Trust Number 5152, party of the first part, and ILLINOIS INDUSTRIAL POLLUTION CONTROL FINANCING AUTHORITY, a public instrumentality and body politic and corporate in the State of Illinois,

party of the second part. WITNESSETH that said party of the first part, in consideration of the sum of TEN (\$10.00) DOLLARS, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said party of the second part, the following described real estate, situated in Cook County, Illinois, to wit:

THAT PART OF THE SOUTH EAST 1/4 OF SECTION 33, TOWNSHIP 39 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN DESCRIBED AS FOLLOWS: COMMENCING AT A POINT IN THE WEST LINE OF SAID SOUTH EAST 1/4 WHICH IS 311.82 FEET NORTH OF THE SOUTH WEST CORNER THEREOF; RUNNING THENCE NORTH ALONG SAID WEST LINE FOR A DISTANCE OF 295.00 FEET TO A POINT; THENCE EASTERLY ALONG A LINE WHICH FORMS AN ANGLE OF 102 DEGREES 14 MINUTES 37 SECONDS MEASURED FROM SOUTH TO EAST WITH THE LAST DESCRIBED LINE FOR A DISTANCE OF 259.35 FEET TO A POINT; THENCE CONTINUING EASTERLY ON A LINE WITH A DEFLECTION OF 3 DEGREES 13 MINUTES 20 SECONDS TO THE RIGHT FOR A DISTANCE OF 379.24 FEET TO THE POINT OF INTERSECTION OF SAID LINE WITH A LINE WHICH IS 626.00 FEET EAST OF AND PARALLEL WITH SAID WEST LINE OF SAID SOUTH EAST 1/4; THENCE SOUTH ON SAID PARALLEL LINE, A DISTANCE OF 409.44 FEET TO THE POINT OF INTERSECTION OF SAID LINE WITH A LINE THAT FORMS A RIGHT ANGLE WITH THE WEST LINE OF SAID SOUTH EAST 1/4 AND PASSES THROUGH THE PLACE OF BEGINNING; THENCE WEST ON SAID RIGHT ANGLE LINE A DISTANCE OF 626.00 FEET TO THE PLACE OF BEGINNING, in Cook County Illinois.

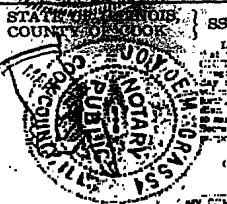

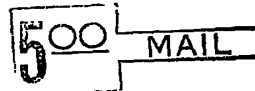
