<p>TRUSTEE'S DEED</p> <p>THIS INDENTURE made this <u>25th</u> day of <u>October</u>, <u>1974</u>, between AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, a corporation duly organized and existing as a national banking association under the laws of the United States of America, and duly authorized to accept and execute trusts within the State of Illinois, not personally but as Trustee under the provisions of a deed or deeds in trust duly executed and delivered to said trustee, containing a recitation in substance of a trust in Trust Agreement, dated the <u>1st</u> day of <u>March</u>, <u>1974</u>, and known as Trust Number <u>328442</u>, party of the first part, and MAX L. EPSTEIN and GLADYS K.
