THE GRANTOR, Village of Rosemont, Cook County, Illinois, a municipal corporation created and existing under and by virtue of the laws of the State of Illinois and duly authorized to transact business in the State of Illinois, for the consideration of TEN AND NO/100 DOLLARS, and other good and valuable considerations in hand paid, and pursuant to authority given by the Board of Trustees of said corporation CONVEYS and QUIT CLAIMS to Robert Collins and Janet Collins, his wife, as joint tenants and not as tenants in common, with right of survivorship of the Village of Rosemont in the County of Cook and State of Illinois all interest in the following described Real Estate situated in the County of Cook in the State of Illinois, to wit:

That part of the South half of Lot 5 in Jarneke's Division of Land in Section 4, Township 40 North, Range 12 and Section 33; Township 41 North, Range 12 East of the Third Principal Meridian, described as follows: Commencing at the Southwest corner of Lot 7 in Jaeger's Resubdivision, being a Resubdivision in Section 4, Township 40 North, Range 12 East of the Third Principal Meridian; thence South along the West line of Lot 7 extended South, a distance of 34.0 feet to a point; thence Southeasterly to a point which is on the East line of Lot 7 extended South a distance of 60.0 feet South of the Southeast corner thereof; thence North along the East line of Lot 7, extended South, a distance of 60.0 feet to the Southeast corner of Lot 7; thence West along the South line of Lot 7 to the place of beginning.
