Lots 1, 13 and 14 in Johnston and Laflin's subdivision of Lots 1, 2 and 3, and part of Lot 4 in Block 2 in fractional Section 15 addition to Chicago in Section 15, Township 39 North, Range 14 East of the third principal meridian;

That part of the alley lying between the east and west lines of Lot 1 aforesaid, extended south to the north line of Lot 13 aforesaid;

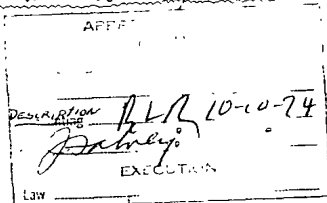
