THAT, WHEREAS First Party has theretofore hereunto executed an instalment note bearing even date herewith in the sum of One Thousand and No/100----(\$1,000.00)-----

DOLLARS,

payable to the order of BEARER, and  
dated as and by which said Note the First Party promises to pay out of that portion of the trust  
trust created by said Trust Agreement and instrument specifically described, the said principal sum  
and interest on the balance of principal remaining from time to time unpaid at the rate of 8.75 per  
cent per annum in instalments as follows: Forty-four and 15/100----(\$44.15)---- DOLLARS/  
or more  
on the 1st day of January 1975, forty-four and 15/100----(\$44.15)---- DOLLARS/  
on the last day of each month thereafter  
until said note is fully paid over, but the final payment of principal and interest, if not sooner  
paid, shall be due on the 1st day of August 1994,  
all such payments in amount of the instalments advanced by said note to be first applied to  
interest on the unpaid principal balance and the remainder to principal; provided that the principal  
of each instalment unless paid when due shall bear interest at the rate of 9.5 per cent  
per annum.

The instalments as follows:

thereafter to and including the day of	19	, with a final payment of the balance due on the day of 19 together with interest on the principal balance from time to time unpaid at the rate of per cent per annum, payable with and at the time for and in addition to each of the said principal instalments; provided that each said instalment of principal shall bear interest after maturity at the rate of per cent per annum;

and all of said principal and interest being made payable at such place in Melrose Park  
Illinois, as the holder or holders of the note may, from time to time, in writing appoint, and in absence  
of such appointment, then at the office of Melrose Park National Bank in said State of Illinois;

NOW, THEREFORE, First Party to secure the payment of the said principal sum of money and  
said interest in accordance with the terms, provisions and limitations of this trust deed, and also in con-  
sideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, does by  
these presents grant, remise, release, and convey unto the Trustee, its successors and assigns, the  
following described Real Estate situated, lying and being in the Village of Melrose Park

COUNTY OF Cook AND STATE OF ILLINOIS, to-wit:

Lot 9 (except the North 1 foot) and all of Lot 10 in Block 135 in Melrose, being a  
Subdivision in Sections 3 and 10, Township 39 North, Range 12, East of The Third  
Principal Meridian, in Cook County, Illinois.

The government of the instrument Note described herein is agreed to deposit with the instrument  
hereof 1/2 of the annual real estate taxes each year.

longing, and all rents, issues and profits thereof for so long and during all such times as First Party, its  
successors or assigns may be entitled thereto (which are reckoned primarily and on a parity with said  
real estate and not secondary), and all apparatus, equipment or articles, now or hereafter therein or  
thereon used to supply heat, gas, air conditioning, water, light, power, refrigeration (whether single  
units or centrally controlled), and ventilation, including (without comprising the foregoing), screens, win-  
dow blinds, storm doors and windows, floor coverings, insulator bats, awnings, stoves and water heaters.  
All of the foregoing are agreed to be a part of said real estate whether physically attached thereto, or  
not, and it is agreed that all similar apparatus, equipment or articles heretofore placed in the premises by  
First Party or its successors or assigns shall be considered as constituting part of the real estate.

NOTE: It is agreed to provide a public easement across the property from Lot 9 to Lot 10.
