Subject to: General taxes for the year 1974 and subsequent years.

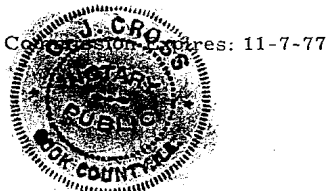
