Witnesseth, That said party of the first part, in consideration of the sum of TELE AND NO/100 Dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said party of the second part, the following described real estate, situated in Cook County, Illinois, to-wit:

Unit 24 in the North 260 Feet of Lots 87 and 88 in Lynwood Terrace Unit No. 1, being a subdivision of the East 1460 Feet of the West 1710 Feet of the South half of the Southwest quarter of Section 7, and the South 80 feet of the North 535 feet of the West 250 feet of the South half of the Southwest quarter of said Section 7, all in Township 35 North, Range 15 East of the Third Principal Meridian in Cook County, Illinois, as delineated on Survey of Lots 87 and 88 which Survey is attached as "Exhibit A-1" to Declaration made by Standard Bank and Trust Company under Document No. 3652, recorded in the office of the Recorder of Cook County, Illinois, as Document No. 21-739-689 dated 1-8-71 and re-recorded as Document No. 21-780-4980 dated 1-18-72; together with an undivided 3.0984 percent interest in said Lots 87 and 88, aforesaid (excepting from said Lot 87 and 88 all the property and space comprising all the units thereon as defined and set forth in said declaration survey) all in Cook County, Illinois.

To Have and to Hold the same unto said party of the second part, and to the proper use and behoof forever of said party of the second part, now as tenants in common but as joint tenants.

Subject to general real estate taxes for 1971 and subsequent years and to Lynwood Terrace Declaration of Covenants, Conditions and Restrictions dated September 1, 1971 and filed and recorded as Document No. 21 633 655 on September 22, 1971.

Party of the First Part also hereby grants to Parties of the Second Part, their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the aforementioned declaration, and party of the first part reserves to itself, its successors and assigns the rights and easements set forth in said declaration for the benefit of the remaining property described therein.

This deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in said declaration, the same as though the provisions of said declaration were recited and stipulated at length herein.

This deed is executed pursuant to and in the exercise of the power and authority granted to and vested in said trustee by the terms of said deed or deeds in trust delivered to said trustee in pursuance of the trust agreement above mentioned. This deed is made subject to the lien of every trust deed or mortgage (if any there be) of record in said county given to secure the payment of money, and remaining unreleased at the date of delivery hereof.

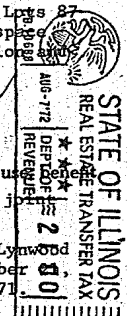

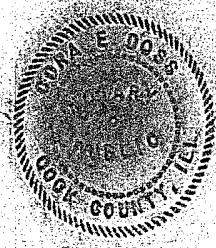
