### ASSIGNMENT AND ASSUMPTION OF DECLARANT RIGHTS

For good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

Assignor, as holder of the Parking Declarant Rights under the Walton South PLA, hereby sells, assigns, transfers, and sets over unto Assignee, all right, title and interest of Assignor in the Parking Declarant Rights under the Walton South REA.

Assignee hereby assumes all obligations of Assignor as to the Parking Declarant Rights under the Walton South REA arising or accruing from and after the date hereof.


This Assignment shall be governed by and construed in accordance with the laws of the State of Illinois.

Without limitation of any representations or warranties expressly set forth in the Agreement, this Assignment constitutes a quitclaim assignment only, and is intended to assign and transfer only such rights which Assignor may have, if any, with respect to the Parking Declarant Rights. In the event of any conflict or inconsistency between the terms hereof and the terms of the Agreement, the terms of the Agreement shall govern and control. Without limitation of the foregoing, all limitations on liability expressly set forth in the Agreement shall apply to this Assignment and the liabilities of the parties hereunder.
