# FIRST AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR 1510 WEST WOLFRAM CONDOMINIUM

This FIRST AMENDMENT TO THE DECLARATION ("Declaration") OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS ("By-Laws") FOR 1510 WEST WOLFRAM CONDOMINIUM ("Association") is made and executed this December 3, 2021, by the undersigned duly authorized agent of the Association.

- A. The Association was created by the recording of the Declaration with respect to the property legally described on Exhibit A hereof with the Recorder of Deeds of Cook County, Illinois as document number 94765895.
- B. Pursuant to the provisions of the Declaration and the By-laws of the Association, the Declaration and the By-laws have been amended at meetings of the Association and the Board of Managers of the Association held on 4/28/21 as set forth herein.
- C. This is the FIRST amendment to the Declaration to this date.
- D. Attached hereto as <u>Exhibit B</u> is an affidavit of an officer of the Association as required by the Declaration and By-laws.

E. The Board of Managers and the Members of the Association find the amendments set forth herein to be in the best interests of the Association and its Members.

NOW THEREFORE, the foregoing recitals are incorporated herein by reference and the Association does hereby declare as follows:

A new Section 28 titled "Restrictions on Smoking" is inserted into the Declaration with the following text:

#### 28. Restrictions on Smoking

- (a) Definitions: (i) "Smoking" means inhaling, exhaling, burning, holding or carrying any lighted eigarette, cigar, cigarillo, pipe or other lighted smoking device for burning tobacco or any other plant product in any manner or in any form. Smoking also includes use of electronic cigarettes (electronic tobacco delivery systems) and hookahs. (ii) "Electronic cigarette" means any electronic device that provides a vapor of liquid nicotine and/or other substances to the user as he/she simulates smoking. The term shall include such devices whether they are manufactured or referred to as e-cigarettes, e-cigars, e-pipes or under any product name. (iii) "Hookah" means glass or metal we expipes shaped somewhat like a bottle with long, flexible hoses with tips that people put into their mouths to inhale tobacco smoke. (iv) "Plant Product" includes marijuana, medical or otherwise.
- (b) Smoking is prohibited everywhere on the Property including, but not limited to, the individual Units and all of the Common Elements (or common areas).
- (c) Notwithstanding the foregoing prohibition, Smoking is permitted ONLY in each Unit's outdoor Limited Common Elements, if any. Any Smoking conducted within a Unit's outdoor Limited Common Elements shall avoid being a ruisance, annoyance, or interruption of the quiet enjoyment of the other Unit owners or guests on the Property, including, inter alia, limiting smells and vapors to a reasonable non-obtrusive amount.
- (d) No owner shall Smoke or permit Smoking by any owner, occupant, agent tenant, contract worker, household worker, guest, friend or family member in violation of this Section.
- (e) Smoking in violation of this policy shall constituent a nuisance, pursuant to the governing documents of the Association. All owners are required to (a) provide to prospective buyers or tenants of their Unit(s) a description of the Association's smoking prohibition and a reference to the smoke free policy; and (b) advise their real estate agents, leasing agents, and prospective buyers of the smoking prohibition prior to the time that a purchase agreement for the unit is entered into.
- (f) In compliance with <u>765 ILCS 605/33</u>, nothing within this Section shall be construed to restrict the consumption of cannabis by methods OTHER than Smoking within a
