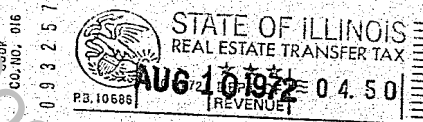

Lot 41 in Block 5 in Corn Products Subdivision, a Subdivision of a portion of the North 1,043 feet of Section 24, Township 38 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois.



together with the tenements and appurtenances thereunto belonging.

To have and to hold the same unto said parties of the second part, and to the proper use, benefit and behoof forever of said parties of the second part, not as tenants in common but as joint tenants.

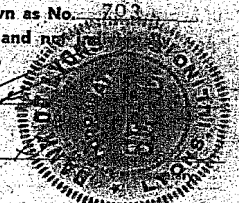

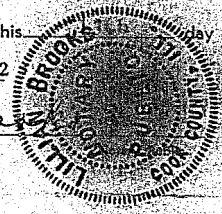
