FIRST AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS PESTRICTIONS, COVENANTS AND BY-LAWS FOR THE 900 WEST CONDOMINIUMS

THIS FIRST AMENDMEN' TO THE DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS COVENANTS AND BY-LAWS FOR THE 900 WEST CONDOMINIUMS is made and entered into this 15th day of December 2021, by THE 900 WEST CONDOMINIUMS ASSOCIATION, ar illinois Not-For-Profit Corporation, hereinafter referred to as "Association."

WITHESSETH

WHEREAS, the Association is the legal titleholder of the real estate in the City of Chicago, County of Cook, and the State of Illinois, legally described in **Exhibit A** attached hereto and made a part hereof.

WHEREAS, the Declaration of Condominium and By-Laws was recorded June 26, 2019, with the Cook County Recorder of Deeds as Document No. 1917745070 ("Declaration"). All defined terms will have the same meaning ascribed to them by the Declaration unless otherwise defined herein;

WHEREAS, Torikago, LLC, an Illinois limited liability company ("Declarant") and the Unit Owners of the Association, desire to amend the Declaration to prohibit smoking of any kind (including, but not limited to, tobacco and cannabis) within the Association ("Amendment"); and

WHEREAS, the Amendment (i) has been approved by the Unit Owners having at least two-thirds (2/3) of the total ownership in the Association's Common Elements at a meeting held for such purpose and (ii) all First Mortgagees have been duly notified (via certified mail) of the Amendment not less than ten (10) days prior to the execution of an affidavit attesting to same, included herewith;

NOW THEREFORE, Article VI of the Declaration is hereby amended to add a new Section 18 as follows (additions in the text are indicated by <u>double underline</u>):

<u>"18. Smoking. Unit Owners, occupants, tenants, and the family members, guests, visitors, employees and invitees of all such Unit Owners, occupants and tenants, shall not smoke</u>

cigarettes, cigars, pipes, tobacco (in any form) or cannabis in, on, or about the Units and the Common Elements, including the Limited Common Elements (except any portion of the Property where the Board may expressly permit smoking), For the purposes of this Paragraph 18, "smoke" and "smoking" mean the inhalation of smoke caused by the combustion of tobacco or cannabis. and "cannabis" means marijuana, hashish, and other substances that are identified as including any parts of the plant Cannabis sativa and including derivatives or subspecies (such as indica) of all strains of cannabis, whether growing or not; the seeds thereof, the resin extracted from any part of the plant; any compound, salt, derivative, mixture, or preparation of the plant, its seeds, or resin, including tetrahydrocannabinol (THC) and all other produced cannabinol derivatives, whether produced directly or indirectly by extraction; and concentrate and cannabis-infused products. The use of electronic cigarettes or other similar implements (to deliver nicotine or THC in aeros of zed or vaporized form) is strictly prohibited in the Common Elements (except in or on any portion of the Property where the Board may expressly permit same)."

EXCEPT TO THE EXTENT EXPRESSLY SET FORTH HEREINABOVE, THE REMAINING PROVISIONS OF THE DECLARATION SHALL CONTINUE IN EFFECT WITHOUT CHANGE.

END OF TEXT OF AMENDMENT

IN WITNESS WHEREOF, on this 15th day of December 2021, this Amendment to the Declaration is executed by the Declarant of the 900 West Condominiums Association, which hereby warrants that it possesses full power and authority to execute this instrument.
