Witnesseth, That said party of the first part, in consideration of the sum of TEN AND NO/100 Dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said party of the second part, the following described real estate, situated in Cook County, Illinois, to-wit:

Unit 107 in the North 282.92 feet of the East 131.50 feet of Lot 89 of Lynwood Terrace Unit No. 1, being a subdivision of the East 1460.00 feet of the West 1710.00 feet of the South half of the Southwest quarter of Section 7, and the South 100.00 feet of the North 535.00 feet of the West 250.00 feet of the South half of the Southwest quarter of said Section 7, all in Township 35 North, Range 15, East of the 1st Principal Meridian, in Cook County, Illinois. As delineated on Survey of Lot 89 which Survey is attached as Exhibit "A-1" to Declaration made by Standard Bank and Trust Company as Trustee under Trust No. 3652, recorded in the office of the Recorder of Cook County, Illinois, as Document No. 21974870 dated 7-13-72; together with an undivided 6.4160 per cent interest in said Lot 89, aforesaid (excepting from said Lot 89 all the property and space comprising all the units thereof as defined and set forth in said Declaration and Survey) all in Cook County, Illinois.

together with the tenements and appurtenances thereunto belonging.

To Have and to Hold the same unto said party of the second part, and to the proper use, benefit and behoof forever of said party of the second part.

Subject to general real estate taxes for 1971 and subsequent years and to Lynwood Terrace Declaration of Covenants, Conditions and Restrictions dated September 21, 1971 and filed and recorded as Document No. 21 633 655 on September 22, 1971.

Party of the First Part also hereby grants to Parties of the Second Part, their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration, and Party of the First Part reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining property described therein.

This deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in said Declaration, the same as though the provisions of said Declaration were recited and stipulated at length hereon.

This deed is executed pursuant to and in the exercise of the power and authority granted to and vested in said trustee by the terms of said deed or deeds in trust delivered to said trustee in pursuance of the trust agreement above mentioned. This deed is made subject to the lien of every trust deed or mortgage (if any there be) of record in said county given to secure the payment of money, and remaining unreleased at the date of delivery hereof.

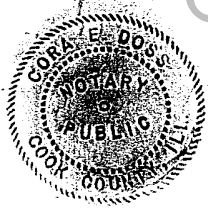

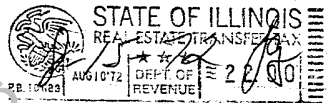
