- 2. The Property is subject to that certain A*fordable Housing Agreement between the Village of Arlington Heights ("Village") and Timber Court, L.L.C, a prior owner of the Property, dated March 20, 2006, and recorded in the office of the Cook County Recorder on April 20, 2006, as Document Number 0611034004 ("Agreement"). The Agreement provides for the construction and maintenance of 21 affordable housing units as part of the development of the Property.
- 3. On September 24, 2021, Owner recorded against the Property as Document Number 2126722043 a restrictive covenant providing for the continued maintenance of the existing affordable housing units on the Property ("Restrictive Covenant"). The Restrictive Covenant provides for the continued maintenance of the existing affordable housing units on the Property.
- 4. The Village and the Owner now desire to terminate the Agreement and to release the Property from the Agreement.

Now Therefore, the Village and the Owner hereby declare that the Agreement is terminated as of the date hereof, and that the Property is hereby released from the Agreement.
