Lot 509 in Northgate Unit 4-B, being a Subdivision in the East Half of Section 8 and the West Half of Section 9, Township 42 North, Range 11 East of the Third Principal Meridian, in Cook County, Illinois.

Together with the tenements and appurtenances thereto adjoining TO HAVE AND TO HOLD the same unto said parties of the second part forever, not in tenancy in common, but in joint tenancy.

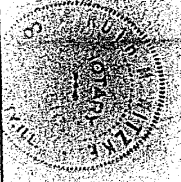
