### MORTGAGE, ASSIGNMENT OF RENTS AND LEASES, SECURITY AGREEMENT AND FIXTURE FILING

THIS MORTGAGE, ASSIGNMENT OF RENTS AND LEASES, SECURITY AGREEMENT AND FIXTURE FILING dated as of February 10, 2022 (this "Mortgage"), is from CLASSIC REAL ESTATE INVESTMENTS LLC, an Illinois limited liability company, and SYREETA HOUSTON, an individual (individually and together, "Mortgagor"), to THE BUDMAN BUILDING, LLC, an Illinois limited liability company ("Mortgagee").

#### **RECITALS**

- A. Mortgagor has, concurrently herewith, executed and delivered to Mortgagee its Promissory Note (the "Note"), bearing even date herewith, payable to the order of Mortgagee, the terms of which are described in Section 2.1 hereof; and
- B. The Note evidences a loan being made by Mortgagee to Mortgagor, for the purpose of providing mortgage financing for the real estate described in **Exhibit A** attached hereto and the improvements located thereon.

### **AGREEMENTS**

FOR GOOD AND VALUABLE CONSIDERATION, including the indebtedness hereby secured, the receipt and sufficiency of which are hereby acknowledged, Mortgagor hereby grants, bargains, sells, conveys and more ages to Mortgagee and its successors and assigns forever, under and subject to the terms and conditions hereinafter set forth, all of Mortgagor's right, title and interest in and to the real estate increted in the City of Chicago, County of Cook, State of Illinois described in <a href="Exhibit A">Exhibit A</a> attached increto and by this reference incorporated herein, including all improvements now and hereafter 1scated thereon;

TOGETHER WITH all right, title and interest of Mortgagor, now owned or hereafter acquired, in and to the following:

- (a) All rents, issues, profits, royalties and income with respect to the said real estate and improvements and other benefits derived therefrom, subject to the right, power and authority given to Mortgagor to collect and apply same; and
- (b) All leases or subleases covering the said real estate and inprovements or any portion thereof now or hereafter existing or entered into, including, without limitation, all cash or security deposits, advance rentals, and deposits or payments of similar nature, and any and all guarantees of the lessee's obligations under any of such leases and subleases, and
- (c) All privileges, reservations, allowances, hereditaments and appurtenances belonging or pertaining to the said real estate and improvements and all rights and estates in reversion or remainder and all other interests, estates or other claims, both in law and in equity, which Mortgagor now has or may hereafter acquire in the said real estate and improvements; and
- (d) All easements, development rights, rights-of-way and rights used in connection with the said real estate and improvements or as a means of ingress and egress thereto, and all tenements, hereditaments and appurtenances thereof and thereto, and all water rights and shares of stock evidencing the same; and

- (e) Any land lying within the right-of-way of any street, open or proposed, adjoining the said real estate and improvements, and any and all sidewalks, alleys and strips and gores of land adjacent to or used in connection with the said real estate and improvements; and
- (f) Any and all buildings and improvements now or hereafter erected on the said real estate, including, but not limited to, all the fixtures, attachments, appliances, equipment, machinery, and other articles attached to said buildings and improvements; and
- (g) All materials intended for construction, reconstruction, alteration and repairs of the said real estate and improvements, all of which materials shall be deemed to be included within the said real estate and improvements immediately upon the delivery thereof to the said real estate; and

- (i) All the estate, interest, right, title and other claims and demands, including claims or demands with respect to any proceeds of insurance related increto, which Mortgagor now has or may hereafter acquire in the said real estate and improvement. or personal property and any and all awards made for the taking by eminent domain, or by any proceeding or purchase in lieu thereof, of the whole or any part of the said real estate and introvements or personal property, including without limitation any awards resulting from a change of grade of streets and awards for severance damages; and
- (j) All of the following which relate to the said real estate and improvements: All present and future plans, specifications, licenses, permits and approvals, all present and future management, supply and other contracts and agreements of every sort, and all present and future obligations and indebtedness owed to Mortgagor thereunder, all present and future intellectual property, and all other present and future general intangibles; and
  - (k) All proceeds of all of the foregoing.

the said real estate and improvements and the property and interests described in (a) through (k) above being collectively referred to herein as the "Property"; and as to any portion of the Property constituting property subject to the Code, this Mortgage is intended to be a security

agreement under the Code for the purpose of creating hereby a security interest in such portion of the Property, which Mortgagor hereby grants to Mortgagee as secured party.

TO HAVE AND TO HOLD the same unto Mortgagee and its successors and assigns forever, for the purposes and uses herein set forth and each of the parties composing Mortgagor hereby RELEASES AND WAIVES all rights under and by virtue of the homestead exemption laws of the State of Illinois.

FOR THE PURPOSE OF SECURING the following (but not exceeding \$650,000 in the aggregate):

- (a) Payment of the indebtedness evidenced by the Note, and including the principal thereof and interest thereon and any and all modifications, extensions and renewals thereof, and performance of all obligations of Mortgagor under the Note; and
- (b) Performance and observance by Mortgagor of all of the terms, covenants and provisions of this Mortgage; and
- (c) Performance and observance by the parties thereto, other than Mortgagee, of all of the terms, covenants, and provisions of the other "Loan Documents" (as defined in Section 1.1 hereof); and
- (d) Payment of all sums advanced by Mortgagee to perform any of the terms, covenants and provisions of this Mortgage or any of the other Loan Documents, or otherwise advanced by Mortgagee pursuant to the provisions hereof or any of such other documents to protect the property hereby mortgaged and pledged; and
- (e) Performance and observance of all of the terms, covenants, and provisions of any other instrument given to evidence or further secure the payment and performance of any indebtedness hereby secured or any obligations secured hereby; and
- (f) Payment of any future or further advances which may be made by Mortgagee at its sole option to and for the benefit of Mortgagor, its successors, assigns and legal representatives.

**PROVIDED, HOWEVER**, that if Mortgagor shall pay the principal and all interest as provided in the Note and shall pay all other sums herein provided for, or secured hereby, and shall well and truly keep and perform all of the covenants herein contained, then this Mortgage shall be released at the cost of Mortgagor, otherwise to remain in full force and effect.

TO PROTECT THE SECURITY OF THIS MORTGAGE AND SECURITY AGREEMENT, MORTGAGOR HEREBY COVENANTS AND AGREES AS FOLLOWS:

#### **ARTICLE I**

#### **DEFINITIONS**

<u>Section 1.1</u>. <u>Definitions</u>. The terms defined in this Section (except as otherwise expressly provided or unless the context otherwise requires) for all purposes of this Mortgage shall have the respective meanings specified in this Section.

"Code" means the Uniform Commercial Code of the State of Illinois as from time to time in effect.

"<u>Default</u>" means, when used in reference to this Mortgage or any other document, or in reference to any provision of or obligation under this Mortgage or any other document, the occurrence of an event or the existence of a condition which, with the passage of time or the giving of notice, or both, would constitute an Event of Default under this Mortgage or such other document, as the case may be.

"Environmental Laws" means the Comprehensive Environmental Response, Compensation, and Liability Act, any so-called "Superfund" or "Superlien" law, and any other federal, state or local statute, law, ordinance, code, rule, regulation, order or decree regulating, relating to, or imposing liability or standards of conduct concerning any Hazardous Material, in each case as 10° v or hereafter in force and effect.

#### "Event of Deizult" means —

- (i) when used in reference to this Mortgage, an Event of Default specified in Section 5.1 hereof; and
- (ii) when used in reference to any other document, a default or event of default under such document that has continued after the giving of any applicable notice and the expiration of any applicable grace or cure periods.

"Guarantor" means Clifton Coleman, an ir dividual.

"Guaranty" means the Guaranty of Payment and Performance dated as of February 10, 2022, from Guarantor to Mortgagee.

"Hazardous Material" means any hazardous substance or any pollutant or contaminant defined as such in, or for purposes of, any federal, state or local statute, law, ordinance, code, rule, regulation, order or decree, in each case as now or hereatter in force and effect; asbestos or any substance or compound containing asbestos; polychlorinated hiphenyls or any substance or compound containing any polychlorinated biphenyl; petroleum and petroleum products; pesticides; and any other hazardous, toxic or dangerous waste, substance or material.

"Impositions" means Impositions as defined in Section 2.6(a) hereof.

"Loan" means the loan to be made by Mortgagee to Mortgagor in accordance with the terms and conditions of the Note and the other Loan Documents.

"Loan Documents" means the Note, this Mortgage, the Guaranty, and all other documents and instruments at any time evidencing and/or securing the indebtedness secured by this Mortgage.

"Mortgage" means this Mortgage, Assignment of Rents and Leases, Security Agreement and Fixture Filing dated as of February 10, 2022, from Mortgagor to Mortgagee.

"Mortgagee" means The Budman Building, LLC, an Illinois limited liability company.

"Mortgagor" means Classic Real Estate Investments LLC, an Illinois limited liability company, and Syreeta Houston, an individual, individually and together, as the context may require.

"Note" means the Promissory Note of Mortgagor dated February 10, 2022, in the principal amount of \$315,000.00, made payable to the order of Mortgagee, and which evidences the Loan.

"<u>Permitted Encumbrances</u>" means those exceptions to title approved by Mortgagee prior to the Closing Date.

"Penitted Materials" means materials customarily used in the construction and maintenance of buildings, and cleaning materials, office products and other materials customarily used in the operation of properties such as the Property, provided that, in each case, such materials are stored, handled, used and disposed of in compliance with applicable laws and regulations and are individually and in the aggregate not in such quantities as may result in contamination of the Property or any part thereof.

"<u>Property</u>" means the real estate described in <u>Exhibit A</u> attached hereto and all improvements now and hereafter located thereon, and all other property, rights and interests described in the foregoing granting clauses of this Mortgage.

### ARTICLE II

#### **COVENANTS AND AGREEMENTS OF MORTGAGOR**

Section 2.1. Payment of Indebtedness. Mortigagor covenants and agrees that it will pay when due the principal of and interest on the indeptedness hereby secured evidenced by the Note, all other sums which may become due pursuant thereto or hereto, and all other indebtedness hereby secured as described in the foregoing transing clauses of this Mortgage, including, but not limited to, all charges, fees and all other sums to be paid by Mortgagor as provided in the Loan Documents, and that it will duly and punctually perform, observe and comply with all of the terms, provisions and conditions herein and in the other Loan Documents provided to be performed and observed by Mortgagor. All amounts payable under this Mortgage shall be paid by Mortgagor without offset or other reduction. The Note secured hereby, which is hereby incorporated into this Mortgage by reference with the carme effect as if set forth in full herein, is in the principal amount of \$315,000.00, and bears interest at a fixed rate of twelve percent (12.00%) per annum. Interest shall accrue and be payable as provided in the Note. All of the unpaid principal of and accrued and unpaid interest on the Note shall be due and payable on February 9, 2023, as such date may be extended pursuant to the terms of the Note.

Section 2.2. Escrow Deposits. In order to provide moneys for the payment of the Impositions on the Property required to be paid by Mortgagor pursuant to Section 2.6 hereof and the premiums on the insurance required to be carried by Mortgagor pursuant to Section 2.4 hereof, Mortgagor shall pay to Mortgagee with each monthly payment on the Note such amount as Mortgagee shall estimate will be required to accumulate, by the date 30 days prior to the due date of the next annual installment of such Impositions and insurance premiums, through substantially equal monthly payments by Mortgagor to Mortgagee, amounts sufficient to pay such next annual Impositions and insurance premiums. All such payments shall be held by

Mortgagee in escrow, and Mortgagee shall not be obligated to pay interest thereon. Amounts held in such escrow shall be made available by Mortgagee to Mortgagor for the payment of the Impositions and insurance premiums on the Property when due, or may be applied thereto by Mortgagee if it in its sole discretion so elects. Notwithstanding anything to the contrary set forth above, Mortgagee acknowledges that it has waived the requirement for the escrow deposits provided for in this Section prior to the occurrence of an Event of Default. Accordingly, Mortgagee shall not initially require Mortgagor to make the escrow deposits provided for in this Section, but upon the occurrence of an Event of Default, Mortgagee may thereafter in its sole discretion elect to require that Mortgagor commence making such escrow deposits by giving Mortgagor not less than 5 days' written notice of such election.

#### Section 2.3. Maintenance, Repair, Alterations. Mortgagor shall --

- (a) Keep the Property in good condition and repair and from time to time make all necess in repairs, renewals, replacements, additions, and betterments thereto so that at all times the Property and the improvements shall be fully preserved and maintained;
- (b) Not remove, demolish or substantially alter any of the improvements which are a part of the Proporty:
- (c) Complete promptly and in a good and workmanlike manner the construction of any improvements (and any renovations thereto) which may be constructed on or at the Property
- (d) Promptly repair and restore any portion of the Property which may become damaged or be destroyed so as to be of at least equal value and of substantially the same character as prior to such damage or destruction;
- (e) Pay when due all claims for labor performed and materials furnished to and for the Property;
- (f) Comply with all laws, ordinances, regulations, covenants, conditions and restrictions now or hereafter affecting the Property or any part thereof or requiring any alterations or improvements;
- (g) Not commit or permit any waste or deterioration of the Property or any portion thereof;
- (h) Keep and maintain the Property and abutting grounds, sidewalks, roads, parking and landscape areas in good and neat order and repair and free of nuisance; and
- (i) Not commit, suffer, or permit any act to be done in or upon the Property in violation of any law, ordinance, or regulation.
- (j) Keep the Property free and clear of all liens and encumbrances of every sort except Permitted Encumbrances.

#### Section 2.4. Required Insurance.

(a) Mortgagor shall at all times provide, maintain and keep in force, or cause to be provided, maintained and kept in force, the following policies of insurance:

- (i) Insurance against loss or damage to the Property by fire and other risks, written on an "all risk" special perils, 100% full replacement cost basis.
- (ii) Commercial general liability insurance on an occurrence basis, against claims for personal injury, including without limitation bodily injury, death or property damage occurring on, in or about the Property and the adjoining streets, sidewalks and passageways, such insurance to afford immediate minimum protection to a limit of not less than \$1,000,000 for one person and \$3,000,000 per occurrence for personal injury or death and \$500,000 per occurrence for damage to property.
- (iii) Workers compensation insurance covering Mortgagor, in accordance with the requirements of Illinois law;
- (iii) During the course of any construction or repair at the Property, all risk builders risk course of construction insurance against all risks of physical loss, on a completed value basis, including collapse and transit coverage, with a deductible not to exceed \$10,000, in nonreporting form, covering the total value of work performed and equipment, supplies and materials furnished, and containing the "permission to occupy" endorsement, and incur.ng all general contractors and subcontractors of any tier.
- (iv) Boiler and machinery insurance covering any pressure vessels, air tanks, boilers, machinery, pressure piping, heating, air conditioning and elevator equipment and escalator equipment located on the Property, and insurance against loss of occupancy or use arising from any breakdown therein, all in such amounts as are satisfactory to Mortgagee.
- (v) Business interruption, use and occupancy or rent loss insurance on the Property covering loss of the use of the Property caused by the perils covered by the policies described in (i) and (iv) above, for a period of 12 months or such longer period as Mortgagee shall require, in an amount not loss than 100% of the projected annual revenue from the Property as determined by Mortgagee, and written on a gross rental income, gross profits or extended period of indemnia form.
- (vi) Such other insurance, and in such amounts, as may from time to time be required by Mortgagee against the same or other hazards
- (b) All policies of insurance required by this Mortgage shall be issued by companies, and in amounts in each company, and in a form, satisfactory to Mortgagee and, without limitation on the generality of the foregoing, shall comply with the following ployisions:
  - (i) All policies of insurance shall be issued by insurance companies having an AM Best's Rating Guide Policy Rating of not less than A and Financial Rating of not less than VIII.
  - (ii) All policies of insurance shall be maintained for and name Mortgagor and Mortgagee as insureds, as their respective interests may appear, and the policies required by paragraphs (a)(i), (iii), (iv), and (v) of this Section shall have attached thereto a standard mortgagee's loss payable endorsement for the benefit of Mortgagee in form satisfactory to Mortgagee.

- (iii) All policies of insurance shall contain an endorsement or agreement by the insurer that any loss shall be payable in accordance with the terms of such policy notwithstanding any act or negligence of Mortgagor or Mortgagee which might otherwise result in forfeiture of said insurance and the further agreement of the insurer waiving all rights of set-off, counterclaim or deductions against Mortgagor, and shall provide that the amount payable for any loss shall not be reduced by reason of coinsurance.
- (iv) All policies of insurance shall contain a provision that they will not be cancelled or amended, including any reduction in the scope or limits of coverage, without at least 30 days' prior written notice to Mortgagee.
- (c) The following notice is provided pursuant to paragraph (3) of Section 180/10 of Chapter 815 of the Illinois Compiled Statutes, as amended. As used herein, "you" means Mortgager and "we" and "us" means Mortgagee: Unless you provide evidence of the insurance coverage required by your agreement with us, we may purchase insurance at your expense to protect our interests in your collateral. This insurance may, but need not, protect your interests. The coverage that we purchase may not pay any claim that you make or any claim that is made against you in connection with the collateral. You may later cancel any insurance purchased by us, but only after providing evidence that you have obtained insurance as required by our agreement. If we purchase insurance for the collateral, you will be responsible for the costs of that insurance, including the insurance premium, interest and any other charges we may impose in connection with the placement of the insurance, until the effective date of the cancellation or expiration of the insurance. The costs of the insurance may be added to your total outstanding balance of obligation. The costs of the insurance may be more than the cost of insurance you may be able to obtain on your own.

#### Section 2.5. Intentionally Deleted.

#### Section 2.6. Taxes and Other Impositions.

- (a) Mortgagor shall pay or cause to be paid at least 10 days prior to delinquency, all real property taxes and assessments, general and special, and all other taxes and assessments of any kind or nature whatsoever, including without limitation any non-governmental levies or assessments such as maintenance charges, owner association dues or charges or fees, levies or charges resulting from covenants, conditions and restrictions affecting the Property, which are assessed or imposed upon the Property, or become due and payable, and which create, may create or appear to create a lien upon the Property, or any part thereof (all of which taxes, assessments and other governmental charges and non-governmental charges of the above-described or like nature are hereinafter referred to as "Impositions").
- (b) Mortgagor shall furnish to Mortgagee within 30 days after the date upon which any Imposition is due and payable by Mortgagor, official receipts of the appropriate taxing authority, or other proof satisfactory to Mortgagee, evidencing the payment thereof.
- <u>Section 2.7.</u> <u>Utilities.</u> Mortgagor shall pay or cause to be paid when due all utility charges which are incurred by Mortgagor or others for the benefit of or service to the Property or which may become a charge or lien against the Property for gas, electricity, water or sewer services furnished to the Property and all other assessments or charges of a similar nature, whether public or private, affecting the Property or any portion thereof, whether or not such assessments or charges are liens thereon.

Section 2.8. Actions by Mortgagee to Preserve Property. Should Mortgagor fail to make any payment or to do any act as and in the manner provided herein or in any of the other Loan Documents, Mortgagee in its own discretion, without obligation so to do and without releasing Mortgagor from any obligation, may make or do the same in such manner and to such extent as it may deem necessary to protect the security hereof. In connection therewith, without limiting its general powers, Mortgagee shall have and is hereby given the right, but not the obligation, (a) to enter upon and take possession of the Property; (b) to make additions. alterations, repairs and improvements to the Property which it may consider necessary and proper to keep the Property in good condition and repair; (c) to appear and participate in any action or proceeding affecting or which may affect the Property, the security hereof or the rights or powers of Mortgagee; (d) to pay any Impositions asserted against the Property and to do so according to any bill, statement or estimate procured from the appropriate office without inquiry into the accuracy of the bill, statement or estimate or into the validity of any Imposition; (e) to pay, purchase, contest or compromise any encumbrance, claim, charge, lien or debt which in the judgment of Mortgagee may affect or appears to affect the Property or the security of this Mortgage or which may be prior or superior hereto; (f) to cure any defaults under any mortgage which is senior to this Mortgage and to pay or purchase the indebtedness secured thereby; and (g) in exercising such powers, to pay necessary expenses, including employment of and payment of compensation to counsel or other necessary or desirable consultants, contractors, agents and other employees. Mortgagor irrevocably appoints Mortgagee its true and lawful attorney in fact, at Mortgagee's election, to do and cause to be done all or any of the foregoing in the event Mortgagee shall be entitled to take any or all of the action provided for in this Section. Mortgagor shall immediately, upon demand therefor by Mortgagee, pay all costs and expenses incurred by Mortgagee in connection with the exercise by Mortgagee of the foregoing rights, including without limitation, costs of evidence of title, court costs, appraisals, surveys and reasonable attorneys' fees and expenses, all of which shall constitute so much additional indebtedness secured by this Mortgage immediately due and payable, with interest thereon from the date of such demand until paid at the Defaul Rate (as such term is defined in the Note).

#### Section 2.9. Damage and Destruction.

- (a) Mortgagor shall give Mortgagee prompt notice of any damage to or destruction of any portion or all of the Property, and the provisions contained in the following paragraphs of this Section shall apply in the event of any such damage of destruction.
- (b) In the case of loss covered by policies of insurance, Mortgagee is hereby authorized at its option either (i) to settle and adjust any claim under such policies without the consent of Mortgagor, or (ii) to allow Mortgagor to agree with the insurance company or companies on the amount to be paid upon the loss; and in any case Mortgagee shall, and is hereby authorized to, collect and receipt for any such insurance proceeds; and the reasonable expenses incurred by Mortgagee in the adjustment and collection of insurance proceeds shall be so much additional indebtedness secured by this Mortgage, and shall be reimbursed to Mortgagee upon demand.
- (c) In the event of any insured damage to or destruction of the Property or any part thereof the proceeds of insurance payable as a result of such loss shall be applied upon the indebtedness secured by this Mortgage or applied to the repair and restoration of the Property, as Mortgagee in its sole discretion shall elect.

(d) In the event that Mortgagee shall elect that proceeds of insurance are to be applied to the repair and restoration of the Property, Mortgagor hereby covenants promptly to repair and restore the same. In such event such proceeds shall be made available, from time to time, to pay or reimburse the costs of such repair and restoration, upon Mortgagee's being furnished with satisfactory evidence of the estimated cost of such repair and restoration and with such architect's certificates, waivers of lien, contractors' sworn statements and other evidence of cost and of payments as Mortgagee may require and approve, and if the estimated cost of the work exceeds 10% of the original principal amount of the indebtedness secured hereby, with all plans and specifications for such repair or restoration as Mortgagee may require and approve. No payment made prior to the final completion of the work shall exceed 90% of the value of the work performed from time to time, and at all times the undisbursed balance of said proceeds remaining in the hands of Mortgagee shall be at least sufficient to pay for the cost of completion of the work, free and clear of any liens.

### Section 113 Eminent Domain.

- (a) Should the Property or any part thereof or interest therein be taken or damaged by reason of any public improvement or condemnation proceeding, or in any other manner, or should Mortgagor receive any notice or other information regarding any such proceeding, Mortgagor shall give prompt written notice thereof to Mortgagee, and the provisions contained in the following paragraphs of this Section shall apply.
- (b) Mortgagee shall be entitled to all compensation, awards and other payments or relief therefor, and shall be entitled at its option to commence, appear in and prosecute in its own name any action or proceedings. Mortgagee shall also be entitled to make any compromise or settlement in connection with such taking or damage. All proceeds of compensation, awards, damages, rights of action and proceeds awarded to Mortgagor are hereby assigned to Mortgagee and Mortgagor shall execute such further assignments of such proceeds as Mortgagee may require.
- (c) In the event that any portion of the Property is taken or damaged as aforesaid, all such proceeds shall be applied upon the indebtedness secured by this Mortgage or applied to the repair and restoration of the Property, as Mortgagee in its sole discretion shall elect.
- (d) In the event that Mortgagee shall elect that such ploceeds are to be applied to the repair and restoration of the Property, Mortgagor hereby coverage promptly to repair and restore the same. In such event such proceeds shall be made available from time to time, to pay or reimburse the costs of such repair and restoration on the terms provided for in Section 2.9(d) hereof with respect to insurance proceeds.
- <u>Section 2.11. Inspection of Property</u>. Mortgagee, or its agents, representatives or workmen, are authorized to enter at any reasonable time upon or in any part of the Property for the purpose of inspecting the same and for the purpose of performing any of the acts it is authorized to perform under the terms of this Mortgage or any of the other Loan Documents. Mortgagee agrees that, except in an emergency, Mortgagee shall provide Mortgagor with not less than 24 hours' prior written notice of any entry under this Section 2.11.

#### Section 2.12. Intentionally Deleted.

#### Section 2.13. Title, Liens and Conveyances.

- (a) Mortgagor represents and warrants that it holds good and marketable title to the Property, subject only to Permitted Encumbrances.
- (b) Except for Permitted Encumbrances, Mortgagor shall not create, suffer or permit to be created or filed against the Property, or any part thereof or interest therein, any mortgage lien or other lien, charge or encumbrance, either superior or inferior to the lien of this Mortgage. In the event that Mortgagor shall suffer or permit any superior or junior lien, charge or encumbrance to be attached to the Property and shall fail to discharge same as described above, Mortgagee, at its option, shall have the unqualified right to accelerate the maturity of the Note causing the full principal balance and accrued interest on the Note to become immediately due and payable without notice to Mortgagor.
  - (c) Intentionally Deleted.
- (d) In the event that Mortgagor shall sell, transfer, convey or assign the title to all or any portion of the Property whether by operation of law, voluntarily, or otherwise, or Mortgagor shall contract to do any of the foregoing, Mortgagee, at its option, shall have the unqualified right to accelerate the maturity of the Note causing the full principal balance and accrued interest on the Note to become immediately due and payable without notice to Mortgagor.
- (e) Any waiver by Mortgages of the provisions of this Section shall not be deemed to be a waiver of the right of Mortgages to insist upon strict compliance with the provisions of this Section in the future.

#### Section 2.14. Environmental Matters.

- (a) Mortgagor hereby represents and warrants to Mortgagee that, with the exception of Permitted Materials, (i) neither Mortgagor nor any of their respective affiliates or subsidiaries, or, to the best of Mortgagor's knowledge, any other person or entity, has ever caused or permitted any Hazardous Material to be placed, held, located or disposed of on, under or at the Property or any part thereof; (ii) none of the property described above has ever been used by Mortgagor or any of its affiliates or subsidiaries, or to the best of Mortgagor's knowledge, by any other person or entity, as a treatment, storage or disposal site, whether permanent or temporary, for any Hazardous Material; (iii) there are no above ground or underground storage tanks located on the Property; and (iv) neither Mortgagor nor the Property is subject to any private or governmental lien or judicial or administrative notice or action pending, or to the best of Mortgagor's knowledge, threatened, relating to Hazardous Materials or the environmental condition of the Property.
- (b) Mortgagor shall not allow any Hazardous Materials other than Permitted Materials to be stored, located, discharged, possessed, managed, processed or otherwise handled on the Property, and shall comply with all Environmental Laws affecting the Property.
- (c) Without limitation on any other provision hereof, Mortgagor hereby agrees to indemnify and hold Mortgagee harmless from and against any and all losses, liabilities, damages, injuries, costs, expenses and claims of any kind whatsoever, including, without

limitation, any losses, liabilities, damages, injuries, costs, expenses or claims asserted or arising under any Environmental Law, paid, incurred or suffered by or asserted against Mortgagee as a direct or indirect result of any of the following, regardless of whether or not caused by, or within the control of, Mortgagor: (i) the presence of any Hazardous Material on or under, or the escape, seepage, leakage, spillage, discharge, emission, discharging or release of any Hazardous Material from the Property or any part thereof, or (ii) any liens against the Property permitted or imposed by any Environmental Law, or any actual or asserted liability or obligations of Mortgagor or any of its affiliates or subsidiaries under any Environmental Law, or (iii) any actual or asserted liability or obligations of Mortgagee or any of its affiliates or subsidiaries under any Environmental Law relating to the Property.

(d) The representations, warranties, covenants, indemnities and obligations provided for ir, this Section 2.14 shall be continuing and shall survive the payment, performance, satisfaction, discharge, cancellation, termination, release and foreclosure of this Mortgage; provided, however, that such representations, warranties, covenants, indemnities and obligations shall not apply with respect to Hazardous Materials which are first placed on the Property on or after the date on which Mortgagee or any other party obtains title to and possession of the Property as a result of an exercise by Mortgagee of its remedies under this Mortgage or any of the other Loan Documents or as a result of a conveyance of title to the Property by Mortgagor to Mortgagee or such other party in lieu of such exercise of remedies.

#### ARTICLE III

#### LEASES; DECLARATION OF SUBORDINATION TO LEASES

Section 3.1. Leases. Mortgagor agrees that (a) it will not enter into any lease of the Property or any portion thereof without the prior written consent of Mortgagee; (b) it will at all times duly perform and observe all of the terms, provisions, conditions and agreements on its part to be performed and observed under any and all leases of the Property or any portion thereof, and shall not suffer or permit any Default or Event of Default on the part of the lessor to exist thereunder; (c) it will not agree or consent to, or suffer or permit, any termination, surrender, modification, amendment or assignment of, or any surlease under, or waive any rights under, any lease of the Property, or any portion thereof; and (d) except for security deposits not to exceed one month's rent for any one lessee, it will not collect any rent for more than one month in advance of the date same is due. Unless otherwise approved by Mortgagee, all leases of space in the Property shall be prepared on a lease form approved by Mortgagee. Nothing herein contained shall be deemed to obligate Mortgagee to perform or discharge any obligation, duty or liability of the lessor under any lease of the Property, and Mortgager shall and does hereby indemnify and hold Mortgagee harmless from any and all liability, loss of damage which Mortgagee may or might incur under any leases of the Property; and any and all such liability, loss or damage incurred by Mortgagee, together with the costs and expenses, including reasonable attorneys' fees and expenses, incurred by Mortgagee in the defense of any claims or demands therefor, whether successful or not, shall be so much additional indebtedness secured by this Mortgage, and Mortgagor shall reimburse Mortgagee therefor on demand.

<u>Section 3.2.</u> <u>Declaration of Subordination to Leases</u>. At the option of Mortgagee, this Mortgage shall become subject and subordinate, in whole or in part (but not with respect to priority of entitlement to insurance proceeds or any award in condemnation) to any and all leases and subleases of all or any part of the Property upon the execution by Mortgagee and recording thereof, at any time hereafter, in the Office of the Recorder of Deeds of the county

wherein the Property is situated, of a unilateral declaration to that effect.

#### **ARTICLE IV**

#### REPRESENTATIONS AND WARRANTIES

<u>Section 4.1</u>. <u>Representations and Warranties</u>. Mortgagor hereby represents and warrants to Mortgagee as follows:

- (a) Classic Real Estate Investments LLC is a limited liability company duly organized, validly existing and in good standing under the laws of the State of Illinois, has all necessary power and authority to carry on its present business, and has full right, power and authority to enter into the Note and Mortgage, to make the borrowings provided for therein and herein, to execute and deliver the Note and the other Loan Documents to which it is a party, and to perform and construct the transactions contemplated hereby and thereby.
- (b) Each of the Loan Documents has been duly authorized, executed and delivered by such of Mortgagor and Guarantor as are parties thereto, and each of the Loan Documents constitutes a valid and legally binding obligation enforceable against such of Mortgagor and Guarantor as are parties thereto. - (b) There is no litigation or administrative proceeding pending or threatened against Mortgagor. There is no Uniform Commercial Code financing statement on file that names Mortgagor as debtor and covers any of the collateral for the Loan, and there is no judgment or tax lien outstanding against Mortgagor.
- (c) All financial statements heretofore and hereaftel delivered to Mortgagee by Mortgagor are and will be true and correct in all material respects.
- (d) Mortgagor has good and marketable title to the Property, subject only to Permitted Encumbrances.
- (e) True, correct and complete copies of all leases of the Property have been furnished to Mortgagee. Each of such leases is in full force and effect and, except as disclosed to Mortgagee, has not been modified or amended. No rental has been paid under any of such leases for more than one month in advance.
- <u>Section 4.2.</u> Continuing Representations and Warranties. The foregoing representations and warranties of Mortgagor shall be continuing and shall survive the execution and delivery of this Mortgage, the other Loan Documents and the disbursement of the Loan. In addition, such representations and warranties relating to Hazardous Material shall survive the payment and performance of the obligations of Mortgagor under the Loan Documents.

Section 4.3. Prohibited Transfers; Use of Proceeds. From and after the date hereof

and so long as the Note is outstanding, Mortgagor covenants and agrees with Mortgagee as follows:

- (a) Classic Real Estate Investments LLC shall preserve and keep in full force and effect its existence as a limited liability company in good standing under the laws of the State of Illinois.
- (b) It is a condition of this Mortgage and the Loan that no Prohibited Transfer shall occur at any time, and Mortgagor covenants and agrees that no Prohibited Transfer will occur at any time. Each of the following shall constitute a "<u>Prohibited Transfer</u>":
  - (i) Any ownership interest in Classic Real Estate Investments LLC shall be transferred or assigned, or any security interest or other lien or encumbrance shall be created on any ownership interest in such Mortgagor or on the proceeds of or distribution lights with respect to any such ownership interest; or
  - (ii) Any ownership interest in any entity that directly or indirectly owns an ownership interest in Classic Real Estate Investments LLC shall be transferred or assigned, or any security interest or other lien or encumbrance shall be created on any ownership interest in any such entity or on the proceeds of or distribution rights with respect to any ownership interest in any such entity.
- (c) No portion of the proceeds of the Loan shall be used by Mortgagor or any of its affiliates, either directly or indirectly, for the purpose of purchasing or carrying any margin stock, within the meaning of Regulation U of the Regulations of the Board of Governors of the Federal Reserve System.

Section 4.4. Tenant Notices. At the time of the first disbursement of the proceeds of the Loan and as a condition thereto, Mortgagor shall celiver to Mortgagee signed notices to tenants of the Property in the form attached to this Mortgage as Exhibit B (the "Tenant Notices"). If any Event of Default shall occur under this Modgage or any of the other Loan Documents, then, without limitation on any other rights or remedies which Mortgagee may have under this Mortgage, any of the other Loan Documents or applicable law. Mortgagee shall have the right, and Mortgagor hereby irrevocably authorizes Mortgagee, (i) to complete the Tenant Notices and to deliver such Tenant Notices to any or all of the then tenants of the Property, and (ii) to deposit all amounts received by Mortgagee in the name of Mortgagor pursuant to the Tenant Notices into a bank account maintained by Mortgagee as security to the Loan. Mortgagee shall apply all amounts from time to time deposited in any such bank account to the payment of the principal of and interest on the Note and other amounts due under the Loan Documents. Mortgagor agrees that it will not take any action to interfere with the exercise by Mortgagee of its rights under this paragraph after the occurrence and during the continuance of any such Event of Default, including, without limitation, any action to induce any tenant of the Property to act otherwise than in accordance with a Tenant Notice delivered to such tenant. Mortgagor acknowledges that the provisions of this paragraph do not constitute an assignment of rents under Illinois law, and that the rights granted to Mortgagee under this paragraph are intended to be, and shall be, enforceable by Mortgagee upon the occurrence and during the continuance of any such Event of Default, whether or not Mortgagee has obtained possession of the Property or the appointment of a receiver for the Property.

**ARTICLE V** 

#### **EVENTS OF DEFAULT AND REMEDIES**

<u>Section 5.1</u>. <u>Events of Default</u>. Any one or more of the following shall constitute an Event of Default under this Mortgage:

- (a) A Default shall occur in the payment when due of any installment of principal of or interest on the Note, or in the payment when due of any other amount required to be paid by Mortgagor to Mortgagee under this Mortgage or under any of the other Loan Documents, or in the payment when due of any other indebtedness secured by this Mortgage; or
- (b) A Default by Mortgagor shall occur under any provision of this Mortgage or of any of the other Loan Documents, relating to the payment by Mortgagor of any amount payable to a party other than Mortgagee and such payment is not made prior to the expiration of any cure period granted by the party to which it is due; or
- (c) Either Mortgagor or Guarantor shall file a voluntary petition in bankruptcy, or shall file any petition or answer seeking or acquiescing in any reorganization, arrangement, composition, readjustment, liquidation, dissolution or similar relief under any present or future federal, state or other statute, law or regulation relating to bankruptcy, insolvency or other relief for debtors; or shall seek or consent to or acquiesce in the appointment of any trustee, receiver or liquidator of such Mortgagor or of all cr any part of the Property, or of any or all of the royalties, revenues, rents, issues or profits thereof, or shall make any general assignment for the benefit of creditors, or shall admit in writin a its or his inability to pay its or his debts generally as they become due; or
- (d) A court of competent jurisdiction shall enter an order of relief pursuant to, or an order, judgment or decree approving, a petition file a against either Mortgagor or Guarantor seeking any reorganization, dissolution or similar relief under any present or future federal, state or other statute, law or regulation relating to bankruptcy, insolvency or other relief for debtors, and such order, judgment or decree shall remain unvacated and a stayed for an aggregate of 10 days, whether or not consecutive, from the first date of entry thereof, or any trustee, receiver or liquidator of either Mortgagor or Guarantor or of all or any part of the Property, or of any or all of the royalties, revenues, rents, issues or profits thereof, shall be appointed and such appointment shall remain unvacated and unstayed for an aggregate of 10 days, whether or not consecutive; or
- (e) A writ of execution or attachment or any similar process shall be issued or levied against all or any part of or interest in the Property, or any judgment involving monetary damages shall be entered against either Mortgagor which shall become a lien on the Property or any portion thereof or interest therein and such execution, attachment or similar process or judgment is not released, bonded, satisfied, vacated or stayed within 10 days after its entry or levy; or
- (f) If any representation or warranty of Mortgagor or Guarantor contained in this Mortgage, in any of the other Loan Documents, or in any statement, certificate or other document delivered in connection with the Loan, shall be untrue or incorrect in any material respect; or

- (g) If any Event of Default by Mortgagor shall occur under any lease of the Property, or if any such lease shall be entered into in violation of the provisions of <u>Section 3.1</u> of this Mortgage; or
- (h) All or any substantial part of the Property shall be taken by a governmental body or any other person whether by condemnation, eminent domain or otherwise; or
- (i) Default shall occur in the performance, observance or compliance with any term, covenant, condition, agreement or provision contained in this Mortgage other than as described in paragraphs (a) through (h) above; or
- (j) If any Event of Default shall occur under any of the other Loan Documents; o
- (k) If any Event of Default shall occur under any other mortgage or trust deed on the Property; or
- (I) Defau't shall occur in the payment of any moneys due and payable to Mortgagee by either Mortgagor or Guarantor, other than in connection with the Loan, or Default shall occur in the performance or observance of any obligation or condition on the part of Mortgagor or Guarantor under any witten contract, agreement or other instrument heretofore or hereafter entered into with Mortgagee other than in connection with the Loan.
- Section 5.2. Acceleration Upon Event of Default; Additional Remedies. Upon or at any time after the occurrence of any Event of Default under this Mortgage, Mortgagee may declare the Note and all indebtedness secured by this Mortgage to be due and payable and the same shall thereupon become due and payable without any presentment, demand, protest or notice of any kind. Thereafter Mortgagee may --
- Either in person or by agent, with cr without bringing any action or proceeding, if applicable law permits, enter upon and take possession of the Property, or any part thereof, in its own name, and do any acts which it deems necessary or desirable to preserve the value, marketability or rentability of the Property, or any part thereof or interest therein, increase the income therefrom or protect the security hereof and, with or without taking possession of the Property, sue for or otherwise collect the rents, issues and profits thereof, including those past due and unpaid, and apply the same to the payment of taxes, insurance premiums and other charges against the Property or in reduction of the indebtedness secured by this Mortgage; and the entering upon and taking possession of the Property, the collection of such rents, issues and profits and the application thereof as aforesaid, shall not cure or waive any Event of Default or notice of Event of Default hereunder or invalidate any act done in response to such Event of Default or pursuant to such notice of Event of Default and, notwithstanding the continuance in possession of the Property or the collection, receipt and application of rents, issues or profits, Mortgagee shall be entitled to exercise every right provided for in this Mortgage or any of the other Loan Documents or by law upon occurrence of any Event of Default; or
- (b) Commence an action to foreclose this Mortgage, appoint a receiver, or specifically enforce any of the covenants hereof; or

- (c) Sell the Property, or any part thereof, or cause the same to be sold, and convey the same to the purchaser thereof, pursuant to the statute in such case made and provided, and out of the proceeds of such sale retain all of the indebtedness secured by this Mortgage including, without limitation, principal, accrued interest, costs and charges of such sale, the attorneys' fees provided by such statute, or in the event of a suit to foreclose by court action, a reasonable attorneys' fee, rendering the surplus moneys, if any, to Mortgagor; provided, that in the event of public sale, such property may, at the option of Mortgagee, be sold in one parcel or in several parcels as Mortgagee, in its sole discretion, may elect; or
- (d) Exercise any or all of the remedies available to a secured party under the Code and any notice of sale, disposition or other intended action by Mortgagee, sent to Mortgagor at he address specified in <u>Section 6.14</u> hereof, at least five days prior to such action, shall constitute reasonable notice to Mortgagor; or
- (c) Exercise any of the rights and remedies provided for in this Mortgage, in any of the other Loan Documents or by applicable law.

Section 5.3. Foreclosure; Expense of Litigation. When the indebtedness secured by this Mortgage, or any palt thereof, shall become due, whether by acceleration or otherwise, Mortgagee shall have the right to foreclose the lien hereof for such indebtedness or part thereof. In any suit to foreclose the lien hereof or enforce any other remedy of Mortgagee under this Mortgage or the Note, there shall be allowed and included as additional indebtedness in the decree for sale or other judgment or decree, all expenditures and expenses which may be paid or incurred by or on behalf of Mortgage's for attorneys' fees, appraiser's fees, outlays for documentary and expert evidence, stenograp ers' charges, publication costs, and costs (which may be estimated as to items to be expended enter entry of the decree) of procuring all such abstracts of title, title searches and examinations, fide insurance policies, and similar data and assurances with respect to title as Mortgagee may deem reasonably necessary either to prosecute such suit or to evidence to bidders at any safe which may be had pursuant to such decree the true condition of the title to or the value of the Property. All expenditures and expenses of the nature in this Section mentioned, and such expenses and fees as may be incurred in the protection of the Property and the maintenance of the lien of this Mortgage, including the fees of any attorney employed by Mortgagee in any litigation or proceeding affecting this Mortgage, any of the other Loan Documents or the Property, including probate and bankruptcy proceedings, or in preparations for the commencement or defense of any proceeding or threatened suit or proceeding, shall be so much additional indebtedness secured by this Mortgage, immediately due and payable, with interest thereon from the date due until paid at the Default Rate. In the event of any foreclosure sale of the Property, the same may be sold in one or more parcels. Mortgagee may be the purchaser at any foreclosure sets of the Property or any part thereof.

Section 5.4. Application of Proceeds of Foreclosure Sale. The proceeds of any foreclosure sale of the Property or of the exercise of any other remedy hereunder shall be distributed and applied in the following order of priority: first, on account of all costs and expenses incident to the foreclosure proceedings or such other remedy, including all such items as are mentioned in Section 5.3 hereof; second, all other items which under the terms hereof constitute indebtedness secured by this Mortgage additional to that evidenced by the Note, with interest thereon as therein provided; third, all principal and interest remaining unpaid on the Note; and fourth, any remainder to Mortgagor, its successors or assigns, as their rights may appear.

Section 5.5. Appointment of Receiver. Upon or at any time after the filing of a complaint to foreclose this Mortgage, the court in which such complaint is filed may appoint a receiver of the Property or any portion thereof. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency of Mortgagor at the time of application for such receiver and without regard to the then value of the Property and Mortgagee or any holder of the Note may be appointed as such receiver. Such receiver shall have power (i) to collect the rents, issues and profits of the Property during the pendency of such foreclosure suit, as well as during any further times when Mortgagor, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits; (ii) to extend or modify any then existing leases and to make new leases, which extension, modifications and new leases may provide for terms to expire, or for options to lessees to extend or ranaw terms to expire, beyond the maturity date of the indebtedness secured by this Mortgage and beyond the date of the issuance of a deed or deeds to a purchaser or purchasers at a foreclosure sale, it being understood and agreed that any such leases, and the options or other such provisions to be contained therein, shall be binding upon Mortgagor and all persons whose interests in the Property are subject to the lien hereof and upon the purchaser or purchasers at any foreclosure sale, notwithstanding discharge of the indebtedness secured by this Mortgage, satisfaction of any foreclosure judgment, or issuance of any certificate of sale or deed to any purchaser; and (iii) all other powers which may be necessary or are usual in such cases for the protection, possessica, control, management and operation of the Property during the whole of said period. The court from time to time may authorize the receiver to apply the net income in his hands in payment in whole or in part of the indebtedness secured by this Mortgage, or found due or secured by any judgment foreclosing this Mortgage, or any tax, special assessment or other lien which may be or become superior to the lien hereof or of such decree, provided such application is made prior to foreclosure sale.

<u>Section 5.6</u>. <u>Insurance After Foreclosure</u>. In case of an insured loss after foreclosure proceedings have been instituted, the proceeds of any insurance policy or policies, if not applied in repairing and restoring the Property, shall be used to pay the amount due in accordance with any judgment of foreclosure that may be entered in any such proceedings, and the balance, if any, shall be paid as the court may direct.
