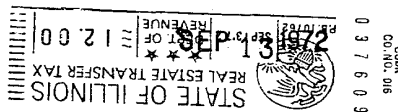

Lots 6 and 7 in George Chases Subdivision of Lot 7 (except the South 30 feet thereof) in the subdivision of Block 1 of Youngs Addition to Blue Island being a subdivision of the East Half of the North East Quarter of Section 36, Township 37 North, Range 13 East of the Third Principal Meridian, in Cook County, Illinois



together with the tenement and appurtenances thereunto belonging.

To Have and to Hold the same unto said party of the second part, and to the proper use, benefit and behoof forever of said party of the second part.

This deed is executed pursuant to and in the exercise of the power and authority granted to and vested in said trustee by the terms of said deed or deeds in trust delivered to said trustee in pursuance of the trust agreement above mentioned. This deed is made subject to the lien of every trust deed or mortgage (if any there be) of record in said county given to secure the payment of money, and remaining unreleased at the date of the delivery hereof.

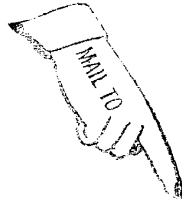
