The East 210 feet (except the West 67.5 feet thereof) of the South 1/9 of the North 9/16 of the East 1/2 of the East 1/2 of the North East 1/4 of the South East 1/4 of Section 11, AND The East 210 feet (except the East 50 feet thereof as measured at right angles to the center line of Roberts Road) of the South 1/10 of the North 5/8 of the East 1/4 of the North East 1/4 of the South East 1/4 of Section 11, Township 37 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois.

together with the tenements and appurtenances thereunto belonging.

**To Have and to Hold** The same unto said parties of the second part forever, not in tenancy in common, but in joint tenancy.

- Subject to:
1. Covenants, conditions and restrictions of record, including easements, if any.
  2. General taxes for 1972 and subsequent years.



This deed is executed pursuant to and in the exercise of the power and authority granted to and vested in said trustee by the terms of said deed or deeds in trust delivered to said trustee in pursuance of the trust agreement above mentioned. This deed is made subject to the lien of every trust deed or mortgage (if any there be) of record in said county given to secure the payment of money, and remaining unreleased at the date of the delivery hereof.

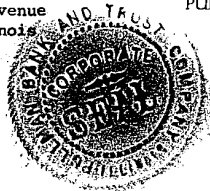

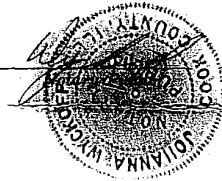
