(FHA-Insured) (FHA COVID-19 Combination Parties Claim and Loan Modification)

This Loan Modification Agreement ("Agreement") between CHRISTINE ORR, AN UNMARRIED WOMAN whose address is 17458 EASTGATE DA, COUNTRY CLUB HILLS, IL 60478 ("Borrower" or "I") and ACTING THROUGH COMMUNITY LOAN SERVICING, LLC, FKA BAYVIEW LOAN SERVICING, LLC ("SERVICER"), AS SUBSERVICER FOR LOAN SERVICER, LAKEVIEW LOAN SERVICING, LLC whose address is 4425 Ponce de Leon Boulevard, 5th Floor, Coral Gables, FL 33145 ("Lender"), is effective 03/01/2022, and amends and supplements (1) the Mortgage, Deed of Trust or Security Deed (the "Security Instrument"), made by CHRISTINE ORR, AN UNMARRIED WOMAN to MERS AS NOMINEE FOR GUARANTEED RATE, INC. for \$162,894.00 and interest, dated 04/16/2018 and recorded on Date 04/25/2018 in Book or Liber __ or as Document/Instrument Number 1811546088, in the Records of Cook, ILLINOIS, and (2) the Note bearing the same date as and secured by the Security Instrument, which was entered into as security for the performance of the Note and encumbers the real and personal property described and defined in the Security Instrument as the "Property," located at 17458 EASTGATE DR COUNTRY CLUB HILLS, IL 60478. This Agreement will not take effect unless the preconditions set forth in Section 2 below have been satisfied.

- 1. My Representations. I certify, represent to Lender, and agree as follows:
 - A. I am experiencing an adverse impact on my ability to make on-time mortgage payments under the Loan Documents due to the COVID-19 pandemic. As a result, (1) I am in default or imminent default under the I oan Documents and (2) I do not have sufficient income or access to sufficient liquid assets to make the monthly mortgage payments due under the Loan Documents.
 - B. I live in, and plan to continue to live in, the Property as my principal residence. The Property has not been condemned and has no material odverse physical condition(s). The Property has no more than four units.
 - C. I am not a borrower on any other FHA-insured mortgage.
 - D. Except as approved in writing by the FHA or Lender, there has been ro change in the ownership of the Property after I signed the Loan Documents.
 - E. Under penalty of perjury, I provided Lender with full and complete information that, when provided, accurately stated my income, expenses, and assets. To the xxint requested by Lender, I provided documents that supported that information. However, I was not required to disclose child support or alimony, unless I chose to rely on such income to qualify for the FHA COVID-19 Combination Partial Claim and Loan Modification ("Modification") or for another loan assistance option.
 - F. I currently have sufficient income to support the financial obligations under the Loan Documents, as modified by this Agreement.

- G. If I received a discharge in a Chapter 7 Bankruptcy proceeding subsequent to the execution of the Loan Documents, Lender agrees that I will not have personal liability on the debt pursuant to this Agreement.
- 2. Acknowledgements and Preconditions to Modification. I understand and acknowledge
 - A. As a precondition to receiving this proposed modification of the Loan Documents, I must accept and fully execute the required subordinate mortgage loan (also called a Partial Claim Note and Security Instrument). I have reviewed and approved the terms of such subordinate loan.
 - B. Leader has no obligation to make any modification of the Loan Documents if any of the requirements under this Agreement has not been met.
 - C. Prior to the Modification Effective Date (as defined in Section 3), if Lender determines that any of my remembrations in Section 1 are no longer true and correct, (1) the Loan Documents will not be modified, (2) this Agreement will not be valid, and (3) Lender will have all of the rights and remedies provided by the Loan Documents.
 - D. The Loan Documents will not be modified unless and until (1) Lender approves this Agreement and (2) the Modifica ion Effective Date (as defined in Section 3 below) has occurred.
 - E. The Loan Documents will not be modified unless and until the modification is approved by the Bankruptcy Court in my bankruptcy case.
- 3. The Modification. If all of my representations in Section 1 above continue to be true in all material respects and all preconditions to the modification set forth in Section 2 above have been met, the Loan Documents will automatically become modification on 03/01/2022 or, if later, the date on which the Bankruptcy Court approves the modification or my bankruptcy case (the "Modification Effective Date") and all unpaid late charges, penaltie, and fees that remain unpaid will be waived. If I have failed to make any payments that are a necondition to this modification, this modification will not take effect.
 - A. The new Maturity Date will be: 02/01/2052
 - B. As of the Modification Effective Date, the new principal balance of my Note will be \$137,141.57 (the "New Principal Balance"). In servicing your loan, the Lender may have incurred third-party fees or charges that were not included in the terms of this Agreement. If so, these fees and charges will appear on your monthly statement under "Fees and Charges." These fees and charges will not accrue interest or late fees. You may pay these fees and charges at any time. If not previously paid, you must pay these fees and charges at the earliest of (1) the date you sell or transfer an interest in the Property, (2) the date you pay the entire New Principal Balance, or (3) the Maturity Date.
 - C. I promise to pay the New Principal Balance, plus interest, to the order of Lender.

D. Interest at the fixed rate of 3.500% will begin to accrue on the New Principal Balance as of 03/01/2022 and my first new monthly payment on the New Principal Balance will be due on 03/01/2022. My fully amortizing payment schedule for the modified Loan is as follows:

The terms in this Section 3.D. supersede any provisions to the contrary in the Loan Documents, including (but not limited to) provisions for an adjustable- or step-interest rate.

- E. I will be in default if I do not comply with the terms of the Loan Documents, as modified by this Agreement.
- F. The interest rate set forth in Section 3.D. above snall apply even in the event of default and if the Loan Documents permitted a default rate of interest.
- 4. Additional Agreements. Lender and I agree to the following:
 - A. I accept the risks of entering into this Agreement. These risks include (but are not limited to)
 - (1) The subordinate lien will require a balloon payment when I pay off, sell, or refinance the Property, which may make these things more difficult to do. The sübordinate lien may also make it more difficult to get additional subordinate lien financing.
 - (2) My modified loan will have a fixed interest rate that will not change. As a result, if the interest rate in my Loan Documents could go up and down based on changes in an index, my new fixed interest rate might sometimes be higher than I would have paid before this modification.
 - B. I authorize Lender to attach an Exhibit A to this loan modification, which will include a Legal Description, recording information of the original security instrument, and any other relevant information required by a County Clerk (or other recordation office) to allow for recording if and when recording becomes necessary for Lender.

- C. All persons, or their authorized representative(s), who signed the Loan Documents have signed this Agreement, unless (1) a borrower or co-borrower is deceased; (2) the borrower and co-borrower are divorced and the Property has been transferred to one spouse in the divorce decree, in which event the spouse who no longer has an interest in the Property need not sign this Agreement (although the non-signing spouse may continue to be held liable for the obligation under the Loan Documents); or (3) Lender waived this requirement in writing. This Agreement may be executed in separate counterparts, each of which shall be deemed an original
- D. This Agreement supersedes the terms of any modification, forbearance, trial period plan, or workout plan that I entered into with Lender.
- E. All terms and provisions of the Loan Documents, except as expressly modified by this Agreement, remain in full force and effect and I will comply with all covenants, agreements, and requirements of the Loan Documents, including (but not limited to) my agreement to make all payments of taxes, insurance premiums, assessments, Escrow Items, impounds, and all other similar obligations, the amounts of which may change in accordance with the terms of my Loan Documents. Except as otherwise specifically provided in, and as expressly modified by, this Agreement, Lender and I will be bound by, and will comply with, all of the terms and conditions of the Loan Documents.
- F. The Loan Documents are duly valid, binding agreements, enforceable in accordance with their terms and are hereby reaffirmed.
- G. On and after the Modification Effective Date, Lender will allow the transfer and assumption of the Loan, including this Agreement, only as permitted under FHA guidelines. Except as noted herein, this Agreement may not be assigned to, or assumed by, a buyer or transferee of the Property.
- H. On and after the Modification Effective Date, any provision in the Note (or in any addendum or amendment to the Note) that allowed for the assersment of a penalty for full or partial prepayment of the Note, is null and void.
- I. I will fully cooperate with Lender in obtaining any title endorsement(s) or similar title insurance product(s) and/or any subordination agreement(s) that are necessary or required by Lender's procedures and/or the Modification to ensure that the Mortgage, as modified by this Agreement, is in first-priority lien position and is fully enforceable. The terms of this Agreement will not become effective, and this Agreement will be null and void, if Lender does not receive such title endorsement(s), title insurance product(s), and/or subordination agreement(s) on or before the Modification Effective Date.
- J. I know that I am only entitled to loss mitigation terms that comply with the Modification. Therefore, if Lender discovers any error in the terms of this Agreement or in the required subordinate mortgage loan, I authorize the Lender to advise me of the error. If I do not accept the corrected terms, at Lender's option, this Agreement becomes void and of no legal effect. If I accept the corrected terms, I will execute and promptly return to Lender the revised and additional documents that will (1) consummate the intended terms and

- K. In addition, I consent to the discussure of my Personal Information and the terms of this Agreement by Lender to (1) any government entity that regulates Lender; (2) any investor, insurer, guarantor, or servicer may owns, insures, guarantees, or services my first lien or subordinate lien (if applicable) mortgage loan(s), (3) companies that perform support services for the Modification, and (4) any HUD-certified housing counseling agency.
- L. If any document relate it to the Loan Documents and/or this Agreement is lost, misplaced, misstated, inaccurately reflects the true and correct terms and conditions of the loan as modified, or is otherwise resising, I will comply with Lender's request to execute, acknowledge, initial, and deliver to Lender any documentation Lender deems necessary. If the original promissory note is replaced, Lender hereby indemnifies me against any loss associated with a demand on the original note. All documents that Lender requests of me under this section shall be referred to 25 the "Replacement Documents". I will deliver the Replacement Documents within ten day: after I receive Lender's written request for such replacement.
