This Indenture, made this 20th day of May, 1972, between CENTRAL NATIONAL BANK IN CHICAGO, a corporation duly organized and existing as a national banking association under the laws of the United States of America, and duly authorized to accept and execute trusts within the State of Illinois, not personally but as Trustee under the provisions of a deed or deeds in trust duly recorded and delivered to said national banking association in pursuance of a certain Trust Agreement, dated the 20th day of May, 1961, and known as Trust Number 4789, party of the first part, and Theodore W. Johnson and Gloria J. Johnson, his wife, 3939 W. 14th St., Chicago 60623 of Cook County, Illinois, not as tenants in common, but as joint tenants, parties of the second part.

WITNESSETH that said party of the first part, in consideration of the sum of \$10.00 Ten and no/100 Dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, not as tenants in common, but as joint tenants, the following described real estate, situated in Cook County Illinois, to-wit:

Lot 3 and the East 8 feet of Lot 4 in Block 4 in Douglas Park Boulevard Bohemian Land Association Subdivision in the North West 1/4 of Section 23, Township 39 North, Range 13, East of the Third Principal Meridian.

together with the tenements and appurtenances thereto belonging.

TO HAVE AND TO HOLD the above granted premises unto the said parties of the second part forever, not in tenancy in common, but in joint tenancy.

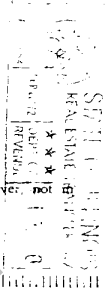
