MEMORAND UM OF MVR HOMEOWNER BENEFIT AGREEMENT

THIS MEMORANDUM OF MVR. 16 MEOWNER BENEFIT AGREEMENT (this "Memorandum"), dated as of the Effective Date, is by and between Christopher L. All capitalized terms used in this Memorandum which are not defined herein shall have the meanings ascribed to them in the Agreement.
