tools and equipment to install roofing, wrap various windows, install gutters and downspouts and do other construction work and services to the Real Estate.

- 3. An additional \$2,147.64 in additional supplements was approved and paid by the insurance company and under the terms of the Installation Agreement this amount is added to the balance.
- 4. From October 14, 2020 until November 7, 2020, the Claimant provided \$8,695.30 worth of labor, material, tools and equipment and other valuable work and services related thereto pursuant to the Agreement and otherwise as allowed by law.
- 5. After allowing all credits due Boroweic for payments made to date, there is due, owing and unpaid to Claimant the sum of \$3,520.89 for which, along with attorney's fees, court costs and interest at the rate of 1.5% per month as allowed by the Agreement, Claimant claims a lien on the Real Estate.
- Claimant last delivered labor, material, tools and equipment to the Real Estate on November 7, 2020, at which time Claimant had completed all work required under the Agreement.
