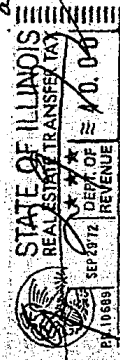
JAMES F. DURISH and SANDRA L. DURISH, his wife, not as tenants in common, but as joint tenants, parties of the second part.

Subject to: General taxes for the year 1972 and subsequent years.



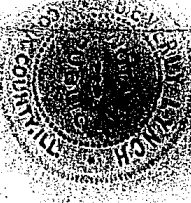
