Lot 223 in Reseda North being a Subdivision of part of the North half of the Southwest quarter of Section 11, Township 42 North, Range 10 East of the Third Principal Meridian, in the Village of Palatine, Cook County, Illinois.



Together with the tenements and appurtenances thereto belonging.

TO HAVE AND TO HOLD the same unto said parties of the second part forever, not in tenancy in common, but in joint tenancy.

This deed is executed pursuant to and in the exercise of the power and authority granted to and vested in said trustee by the terms of said deed or deeds in trust delivered to said trustee in pursuance of the trust agreement above mentioned. 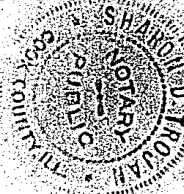
