#### DCEO USE RESTRICTION AGREEMENT

THIS DCEO USE RESTRICTION AGREEMENT (the "Agreement") is made as of March 18th, 2022 by and among The Illinois Department of Commerce and Economic Opportunity ("Grantor"), Academy for Global Citizenship Charter School, an Illinois not-for-profit corporation ("Grantee"), and Academy For Global Citizenship Support Corporation, an Illinois not-for-profit corporation ("Grantee Affiliate").

#### RECITALS

WHEREAS, Grantor and Grantee entered into that certain Grant Agreement (Agreement No. 21-203266) as fully executed on May 11, 2021 (the "Original Agreement"):

WHEREAS, Grantor and Grantee entered into that certain First Amerument to Grant Agreement dated on or about the date hereof (the "Amendment" and with the Original Agreement, the "Grant Agreement");

WHEREAS, pursuant to the Grant Agreement, Grantor agreed to provide Grant Funds (as defined in the Original Agreement) in an amount not to exceed \$31,000,000 to Grantee for the development of a Community Learning, Wellness, and Sustainability Hub;

WHEREAS, Grantor's execution of the Amendment was conditioned on Grantee agreeing to certain use restrictions as further described herein; and

WHEREAS, on or about the date hereof, Grantee is conveying certain real estate (the "Property") in the City of Chicago, County of Cook, State of Illinois, legally described on *Exhibit A* attached hereto to Grantee Affiliate subject to such use restrictions.

NOW, THEREFORE, to assure Grantor of the performance by Grantee and Grantee Affiliate of the conditions contained in the Grant Agreement, the Grantee and Grantee Affiliate hereby acknowledge and agree:

- 1. <u>USE RESTRICTIONS</u>. The Property shall be used for non-profit purposes (the "Use Restrictions"). The Property shall be used consistent with the Use Restrictions until the expiration of the records retention period describe in Section 12.1 of the Grant Agreement. Upon the expiration of such period; Grantor shall deliver to Grantee Affiliate or any subsequent owner of the Property, a release of this Agreement in recordable form.
- 2. **BINDING NATURE OF COVENANTS**. This Agreement shall run with the land and shall bind and inure to the benefit of the parties, their successors and assigns, and every party now or never fter acquiring any right, title, or interest therein or in any part thereof; provided, however, this Agreement shall not encumber or bind any other real estate owned by Grantee or Grantee Aftiliate other than the Property.
- 3. **ENFORCEMENT**. Enforcement of the foregoing restrictive covenant shall be by proceedings at law or in equity against any person or persons violating or attempting to violate such covenant to restrain violation. Such action may be brought by Grantor.
- 4. <u>ATTORNEYS' FEES</u>. 'my person who successfully brings an action for enforcement of this Declaration shall be entitled to recover attorneys' fees and costs for such action, including any successful appellate proceedings, from the then owner of the affected portion or portions of the Property.
- 5. REPRESENTATIONS. Each party to this Agreement represents and warrants to the other parties hereto that (i) it is duly organized and validity existing under the laws of its state of organization, (ii) that this Agreement has been duly authorized by such party by all necessary corporate and/or legislative action, as applicable, (iii) that the individual executing this Agreement on such party's behalf is duly authorized to do so, and (iv) that this Agreement constitutes the legal, valid and binding obligation of such party.
- 6. MISCELLANEOUS. This Agreement may be executed in multiple counterparts and the signature page(s) and acknowledgment(s) assembled into one original document for recordation, and the validity hereof shall not be impaired by reason of such execution in multiple counterparts. This Agreement is to be governed according to the laws of the State of Illinois. If any provision of this Agreement shall be invalid, illegal or unenforceable, it shall not affect or impair the validity, legality and enforceability of the other provisions of this Agreement.
