Lender shall not be required to commence proceedings against any successor in interest or refuse to extend time for payment or otherwise modify amortization of the sums secured by this Security Instrument by reason of any demand made by the original Borrower or Borrower's successors in interest. Any forbearance by Lender in exercising any right or remedy shall not be a waiver of or preclude the exercise of any right or remedy.
- 3. Successors and Assigns Bound; Joint and Several Liability; Co-signers. The covenants and agreements of this Security Instrument shall bind and benefit the successors and assigns of Lender and Borrower. Borrower's covenants and agreements shall be joint and several. - 4. Notices. - 5. Governing Law; Severability. This Security Instrument shall be governed by Federal law and the law of the jurisciction in which the Property is located. In the event that any provision or clause of this Security Instrument or the Note conflicts with applicable law, such conflict shall not affect other provisions of this Security Instrument or the Note which can be given effect without the conflicting provision. To this end the provisions of this Security Instrument and the Note are declared to be severable.

The notice shall further into the Borrower of the right to reinstate after acceleration and the right to assert in the foreclosure proceeding the the existence of a default or any other defense of Borrower to acceleration and foreclosure. If the default is accelered on or before the date specified in the notice, Lender at its option may require immediate payment in fall of all sums secured by this Security Instrument without further demand and may foreclose this Security Instrument by judicial proceeding. Lender shall be entitled to collect all expenses incurred in pursuing the remadies provided in this Section 7, including, but not limited to, reasonable attorneys' fees and costs of title evidence.
