MEMORANDUM OF MVR HOMEOWNER BENEFIT AGREEMENT

THIS MEMORANDUM OF MVR. I/CMEOWNER BENEFIT AGREEMENT (this "Memorandum"), dated as of the Effective Date, is by and between K/ASTY M.
