- 4) Parcel 2, at line 9, incorrectly omits the following language: "THENCE NORTH 73 DEGREES 12 MINUTES 39 SECONDS EAST A DISTANCE OF 10 FEET" between "POINT OF BEGINNING" and "THENCE NORTH 16 DEGREES..."
