### MASTER A SSIGNMENT OF MORTGAGES AND DEEDS OF TRUST AND ASSUMPTION AGREEMENT

Dated as of July 19, 2021 and effective as of May 26, 2021

This MASTER ASSIGNMENT OF MCRTGAGES AND DEEDS OF TRUST AND ASSUMPTION AGREEMENT (this "Agreement") is riade by WELLS FARGO BANK, NATIONAL ASSOCIATION, having an address of MAC D1109-019, 152.5 W, W T Harris Blvd, 1st Floor, Charlotte, NC 28262-8522, in its capacity as resigning Administrative Agent under the Credit Agreement described below (in such capacity, the "Resigning Agent") and TRUIST BANK, having an address of 303 Peachtree Street, N.E., Atlanta, Georgia 30308, Attention: Portfolio Manager, in its capacity as successor Administrative Agent under the Credit Agreement (in such capacity, the Successor Agent").

#### RECITALS

WHEREAS, Blueknight Energy Partners, L.P., a Delaware limited partners nip ("Borrower"), has entered into that certain Second Amended and Restated Credit Agreement, dated as of M.y 11, 2017, by and among Borrower, Resigning Agent, as administrative agent, and the other agents and lenders party thereto (as amended prior to May 26, 2021, the "Existing Credit Agreement"), pursuant to which the lenders party thereto severally agreed to make extensions of credit to Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, the obligations of the Loan Parties under the Existing Credit Agreement are secured by, among other things, those certain Deed of Trust (for Arizona, California, Mississippi, Missouri, Montana, Nebraska, Nevada, North Carolina, Tennessee, Texas, Utah, and Washington), Credit Line Deed of Trust (Virginia), Mortgage (for Alabama, Arkansas, Colorado, Idaho, Illinois, Indiana, Kansas, New Jersey, Oklahoma, and Wyoming), Open End Mortgage (for Ohio and Pennsylvania), Deed to Secure Debt (Georgia), Assignment of Leases and Rents, Security Agreement, Fixture Filing and Financing Statement instruments, dated of even date with the Existing Credit Agreement, each recorded in the office designated for the filing of record of a mortgage or deed of trust (as applicable) in the jurisdictions listed in Exhibit A

hereto (as amended, supplemented or otherwise modified prior to the date hereof, collectively, the "Existing Mortgages");

WHEREAS, Borrower has entered into that certain Third Amended and Restated Credit Agreement, dated as of May 26, 2021 (the "Amended and Restated Credit Agreement"), among Borrower, Successor Agent, and the other agents and Lenders party thereto, pursuant to which the Existing Credit Agreement was amended and restated in its entirety (the Existing Credit Agreement, as so amended and restated by the Amended and Restated Credit Agreement, and as the same may be further amended, restated, renewed, replaced, supplemented, consolidated, extended or increased in amount or otherwise modified from time to time, the "Credit Agreement"; unless otherwise defined herein, capitalized terms used in this Agreement shall have the respective meanings assigned to them in the Credit Agreement); and

WEEPLAS, the Resigning Agent has agreed to assign and the Successor Agent has agreed to assume all of the Resigning Agent's rights, interests and obligations as Administrative Agent under the Credit Agreement, including all of the Resigning Agent's rights, interests and obligations as Administrative Agent under the Existing Mortgages, as more particularly described below;

**NOW THEREFOR'** in consideration of the premises and the mutual covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are acknowledged, the parties hereto agree as follows:

#### **AGREEMENT**

#### Section 1. Assignment of Interes's and Liens.

- (a) The Resigning Agent, as Administrative Agent under the Existing Credit Agreement and other Loan Documents, has GRANTED, SOLD, REMISED, CONVEYED, CONFIRMED, ASSIGNED, TRANSFERRED, SET OVER, and DELIVERED, and does by these presents GRANT, SELL, REMISE, CONVEY, CONFIRM, ASSIGN, TRANSFER, SET OVER, and DELIVER, unto the Successor Agent, and to its successors and assigns, all rights, titles, interests, licus, security interests, pledges, assignments, privileges, claims, demands and equities granted to the Resigning Agent in its capacity as the holder, mortgagee, assignee or beneficiary of the security under or pursuant to the terms and provisions of the Existing Mortgages (hereinafter collectively called the "Liens and Security Interests"), and the Successor Agent hereby accepts and assumes such GRANT, SALE, REMISE, CONVEYANCE, CONFIRMATION, ASSIGNMENT, TRANSFER, SETTING OVER, and DELIVERY of the Liens and Security Interests.
- (b) TO HAVE AND TO HOLD the Liens and Security Interests unto the Si cressor Agent, as successor Administrative Agent, and its successors and assigns, forever.
- (c) The parties hereto agree that the foregoing assignment is made without any covenant, representation or warranty of any kind, express or implied or by operation of law.

#### Section 2. <u>Miscellaneous</u>.

- (a) This Agreement binds the parties hereto and their successors and permitted assigns.
- (b) THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, except to the extent that the assignment of any Liens and Security Interests is mandatorily governed by the laws of the jurisdiction in which the properties subject thereto are located. This Agreement is a Loan Document.
