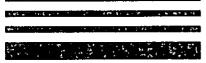

- (a) All meet inery, equipment, fixtures (including, but not limited to, all heating, air conditioning, plumbing, lighting, communications and elevator fixtures), furniture, software used in or to operate any of the foregoing and other property of every kind and neture whatsoever owned by Debtor, or in which Debtor has or shall have an interest, now or hereafter located upon the Property and all building equipment, materials and supplies of any nature whatsoever owned by Debtor, or in which Debtor has or shall have an interest, now or hereafter located upon the Property, or appurtenant thereto, or usable in connection with the present or future operation and occupancy of the Property, and the right, title and interest of Debtor in and to any of the foregoing personal property which may be subject to any security interests, as defined in the Uniform Commercial Code, as adopted and enacted by the state or states where any of the Collateral is located, and all proceeds and products of the above;
- (b) All right, title and interest of Debtor, its successors and assigns in and under all leases, subleases, subsubleases, lettings, licenses, concessions or other agreements (whether written or oral) pursuant to which any person is granted a possessory interest in, or right to use or occupy all or any portion of the Property ("Leases"), including, without limitation, cash or securities deposited thereunder to secure the performance by the lessees of their obligations thereunder and all rents, additional rents, rent equivalents, moneys payable as demages or in lieu of rent or rent equivalents, royalties (including, without limitation, all oil and gas or other mineral royalties and sonuses), income, receivables, receipts, revenues, deposits (including, without limitation, security, utility and other deposits).
