4. Having previously deposited the final just compensation award in the amount of **TWO HUNDRED TEN THOUSAND AND 00/100 DOLLARS (\$210,000.00)** on July 15, 2021, Plaintiff has satisfied its obligations in accordance with the Agreed Final Judgment Order entered in this matter.


IT IS FURTHER ORDERED:

4. The compensation award of **TWO HUNDRED TEN THOUSAND AND 00/100 DOLLARS (\$210,000.00)** deposited on July 15, 2021, by Plaintiff with the Cook County Treasurer, is the full and final just compensation to be awarded interested parties in this matter;

5. Plaintiff has satisfied the full and final judgment entered herein with respect to Defendants and interested parties; and

6. The Order entered on August 3, 2021 vesting the MWRD with the easement interests is confirmed.
