NOW THEREFORE, the Association hereby declares that the Amended and Restated Declaration be and is hereby amended as follows:

The Association hereby declares that the Amended and Restated Declaration be and hereby is amended with regard to Article 6, Section 6.01, and said Section 6.01 is amended by deleting the last sentence in its entirety and replacing same with the following:

Any amount accumulated in excess of the amount required for actual expenses and reserves may, in the Board's discretion, be placed into the Association's reserve accounts and/or applied to the succeeding year's annual budget.

Except as expressly set forth herein, the Amended and Restated Declaration shall remain in full force and effect in accordance with its terms. The effective date of this amendment shall be deemed the date of recording with the office of the Recorder of Cook County.


