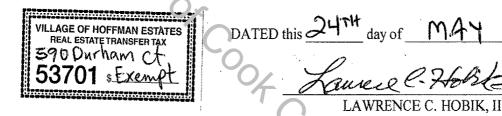
he or they were duly appointed and are fully invested into the title, estate, rights, powers and duties of the preceding Trustee.
