THIS INDENTURE, made this 4th day of December, 1972, between NORTHWEST NATIONAL BANK OF CHICAGO, a national banking association of Chicago, Illinois, as Trustee under the provisions of a deed or deeds in trust, duly recorded and delivered to said bank in pursuance of a trust agreement dated the 2nd day of February, 1971, and known as Trust Number 1007, party of the first part, and GERALD C. GARDNER and DORIS E. GARDNER, his Wife parties of the second part.

WITNESSETH, that said party of the first part, in consideration of the sum of Ten and no/100 (\$10.00) dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, not as tenants in common, but as joint tenants, the following described real estate, situated in Cook County, Illinois, to-wit: SEE ATTACHED RIDER

That part of Block 2 in Valley Lo-Unit Five, being a Subdivision in Section 23, Township 42 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois, described as follows: Beginning on the north line of said Block 2, at a point which is 1413.87 feet east from the northwest corner of said Block 2, and running thence south along a line perpendicular to said north line of Block 2, a distance of 310.0 feet to the north line of Wildberry Drive; thence east along said north line of Wildberry Drive, being here a straight line, a distance of 70.47 feet to a point of curve; thence southeastwardly along the northeasterly line of Wildberry Drive, being here the arc of a circle convex to the northeast and having a radius of 80 feet, a distance of 33.56 feet to an intersection with a line which is perpendicular to the north line of said Block 2, and which intersects the north line of said Block 2 at a point which is 1516.93 feet east from the northwest corner of said Block 2; thence north along said last described perpendicular line, a distance of 316.94 feet to said north line of Block 2, and thence west along said north line of Block 2, a distance of 103.06 feet to the point of beginning. Commonly known as 1716 Wildberry Drive, Glenview, Illinois.

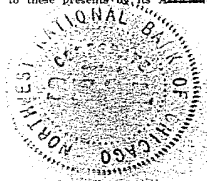
