- 15. Governing Law; Severability. This Security Instrument shall be governed by federal law and the law of the jurisdiction in which the Property is located. As used in this paragraph 20, "Environmental" Law" means federal laws and laws of the jurisdiction where the Property is located that relate a nealth, safety or environmental protection.

21. Acceleration; Remedies. 
