THE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED) AND WHICH FORM A PART OF THE TRUST DEED WHICH THERE BEGINS:

- 1. Mortgagors shall (1) keep said premises in good condition and repair, without waste; (2) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) keep said premises free from mechanic's liens or liens in favor of the United States or other liens or claims for lien other expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory now or at any time in process of erection upon said premises; (6) comply with all requirements of law or municipal ordinances with respect the premises and the use thereof; (7) make no material alterations in said premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.
- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note the original or duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all buildings and improvements own or hereafter situated on said premises insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the note, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the holders of the note, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies, including additional and renewal policies, to holders of the note, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.

 4. In case of default therein, Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mortgagors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem of many tax sale or forfeiture affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including reasonable attorneys' fees, and any other moneys advanced by Trustee or the chief to often note to protect the mortgaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning pay ole without notice and with interest thereon at the rate of seven per cent per annum. Inaction of Trustee or holders of the note shall never be concerned as a waiver of any right accruing to them on account of any default hereunder on the part of Mortgagors.
- The rustee or the holders of the note hereby secured making any payment hereby authorized relating to taxes or assessments, may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or a may so into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.

- 9. Upon or at any time after the filling of a complaint to foreclose thi Tru. Deed, the Court in which such complaint is filed may appoint a receiver of said premises. Such appointment may be made either before or at any line without notice, without regard to the solvency or insolvency of Mortgagors at the time of application for such receiver and without regard to lie to envalue of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereunder may be appointed as such acc. ver. Such receiver shall have power to collect the rents, issues and profits of said premises during the pendency of such foreclosure suit and, if call even and a deficiency, during the full statutory such receiver, would be entitled to collect such rents, issues and profits, and all other power which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the premises during and whole or in part of:

- 10. No action for the enforcement of the lien of this Trust Deed or of any provision hereof shall subject to any defense which would not be good and available to the party interposing same in an action at law upon the note hereby secured.
- 11. Trustee or the holders of the note shall have the right to inspect the premises at all reasonable mes and access thereto shall be per mitted for that purpose.
- 12. Trustee has no duty to examine the title, location, existence, or condition of the premises, nor shall frust be obligated to reconthis Trust Deed or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable or any acts or omission thereunder, except in case of his own gross negligence or misconduct or that of the agents or employees of Trustee, and he may require indemnitial satisfactory to him before exercising any power herein given.
- 33. Trustee shall release this Trust Deed and the lien thereof by proper instrument upon presentation of satisfactory widence that all indebtedness secured by this Trust Deed has been fully paid; and Trustee may execute and deliver a release hereof to and a the eccut of any person who shall either before or after maturity thereof, produce and exhibit to Trustee the principal note, representing that all not underess such successor trustee may accept as true without inquiry.
