### ORDER

This cause coming to be heard on Plaintiff's Motion for Default Judgment on Count I of Complaint, due notice having been given, the Court having found that Defendant Lakeisha M. Robinson was personally served with process relating to this lawsuit on April 27, 2022 and that Defendant's failure to pay for the construction services furnished on her behalf is vexatious for purposes of Section 2 of the Illinois Interest Act, 815 ILCS 205/2, the Court being otherwise fully advised in the premises;

#### IT IS HEREBY ORDERED THAT:

1. Plaintiff's Motion for Default Judgment on Count I of Complaint is granted.
2. Default judgment is entered in favor of Plaintiff Real Restoration Group, Inc. and against Defendant Lakeisha M. Robinson on Count I of the Complaint in the amount of \$16,098.57, which sum is comprised of the unpaid balance due for construction services furnished on her behalf (\$15,428.59) plus statutory prejudgment interest on this sum at the rate of 5% per annum from July 14, 2021 through May 27, 2022 (\$669.98), plus costs in the amount of \$388.00.
3. Count II of the Complaint is voluntarily dismissed without prejudice as moot.
4. Plaintiff shall cause a copy of this order to be mailed to Defendant within two (2) business days.
