IE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE THIS TRUST DEED) AND WHICH FORM A PART OF THE TRUST DEED WHICH THERE BEGINS:

- 1. Mortgagors shall (1) keep said premises in good condition and repair, without waste: (2) promptly repair, restore, or rebuild any nechanics lies or lies in favor of the United States or other liens or claims for lien or expressly subordinated to the lien hereof; (4) pay when the any indebtedness which may be scene damaged or be subordinated to the lien hereof; (4) pay when the any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory own or at any time in process of exection upon said premises; (6) complete within a reasonable time any buildings or buildings or buildings are premises and the use thereof; (7) make no material alterations in said premises except as required by law or municipal ordinances with respect to revivously consented to in writing by the Trustee or holders of the note.
