

#### IT IS HEREBY ORDERED THAT

- 4021 1. Plaintiff's Motion for Summary Judgment is granted.
- 4190 2. Summary judgment is entered on Count I of the Complaint in favor of Plaintiff JPMorgan Chase Bank, N.A. and against Defendant Foot & Ankle Health Care Center, Ltd. in the amount of \$262,719.90, which sum consists of the unpaid principal balance of the promissory note executed by Foot & Ankle Health Care Center, Ltd. dated April 18, 2012 in the original principal sum of \$250,000.00 (\$212,025.55), unpaid accrued interest thereupon (\$3,312.30), contractual attorneys' fees incurred by Plaintiff through May 10, 2022 (\$46,574.94), and allowable costs (\$806.61).

Summary judgment is entered on Count II of the Complaint in favor of Plaintiff JPMorgan Chase Bank, N.A. and against Defendants Vadim Goshko and Galina Podolskiy (who is also known as Galina Podolskaya), jointly and severally, in the amount of \$262,719.90, which sum consists of the unpaid principal balance of the promissory note executed by Foot & Ankle Heath Care Center, Ltd. dated April 18, 2012 in the original principal sum of \$250,000.00

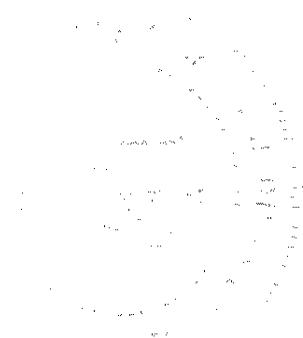
