ASSOCIATE JUDGE'S DEED

WHEREAS, on the 24th day of January, 1972, in case number 71 D 8476 entitled RUTH E. BISHOP vs. ROBERT A. BISHOP, plaintiff was granted a judgment for divorce from said ROBERT A. To have and to hold the same, with all the appurtenances thereto belonging, to the said RUTH E. BISHOP, her heirs and assigns forever.

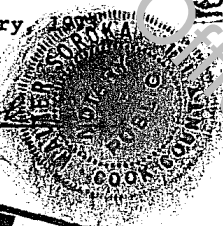
