**MEMORANDUM OF INTER-CREDITOR AGREEMENT**

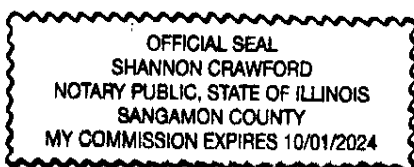
