THIS INDENTURE, made this 29th day of January, 1973, between NORTHWEST NATIONAL BANK OF CHICAGO, a national banking association of Chicago, Illinois, as Trustee under the provisions of a deed or deeds in trust, duly recorded and delivered to said bank in pursuance of a trust agreement dated the 2nd day of February, 1971, and known as Trust Number 1007, party of the first part, and MARTIN S. GOLDMAN and parties of the second part, --- SUSAN G. GOLDMAN, his Wife ---

WITNESSETH, that said party of the first part, in consideration of the sum of Ten and no/100 (\$10.00), --- dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, not as tenants in common, but as joint tenants, the following described real estate, situated in Cook County, Illinois, to-wit: SEE ATTACHED RIDER

Unit No. 14-F as delineated on the survey of the following described parcel of real estate (hereinafter referred to as "Parcel"):

That part of Block 2 in Valley Lo-Unit Five, being a Subdivision in Section 23, Township 42 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois, described as follows: Beginning on the north line of said Block 2, at a point which is 1084.54 feet east from the northwest corner of said Block 2, and running thence south along a line perpendicular to said north line of Block 2, a distance of 286.41 feet to the northeasterly line of Wildberry Drive; thence southeastwardly along said northeasterly line of Wildberry Drive, being here a straight line, a distance of 25.07 feet, to a point of curve; thence continuing southeastwardly along said northeasterly line of Wildberry Drive, being here the arc of a circle convex to the southwest and having a radius of 20 feet, a distance of 15.71 feet to a point of tangent in that north line of Wildberry Drive which is 310.0 feet south from the north line of said Block 2; thence east along said north line of Wildberry Drive, a distance of 63.46 feet to an intersection with a line which is perpendicular to the north line of said Block 2 and which intersects the north line of said Block 2 at a point which is 1179.87 feet east from the northwest corner of said Block 2; thence north along said last described perpendicular line, a distance of 310.0 feet to said north line of Block 2, and thence west along said north line of Block 2, a distance of 95.33 feet to the point of beginning. Grantor furthermore expressly grants to the parties of the second part, their successors and assigns, as rights and easements appurtenant to the above-described real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration, and the rights and easements set forth in other Declarations of Condominium Ownership whether heretofore or hereafter recorded affecting other premises in Block 2 in Valley Lo Unit Five Subdivision aforesaid, including, but not limited to, the easements for ingress and egress set forth therein.

This conveyance is made subject to all rights, benefits, easements, restrictions, conditions, reservations and covenants contained in said Declaration, and the grantor expressly reserves to itself, its successors and assigns, the rights, benefits and easements set forth in said Declaration for the benefit of all remaining property described in said survey or said Declaration.

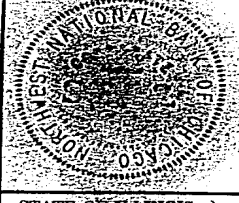

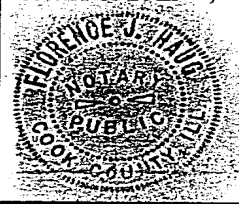
