NARRATIVE DESCRIPTION OF PROJECT

The Property, located at 2536-48 West Madison Street, Chicago, Illinois, is comprised of four (4) vacant City parcels measuring approximately 43,296 square feet and situated within the boundaries of the Midwest Tax Increment Financing Redevelopment Project Area upon which the Developer intends to develop a three (3) story, 60,000 square foot building to house an ice rink facility which shall be used for the youth Chicago Jets Hockey Club and adult hockey leagues and also is slated to become the new practice facility for Chicago's NHL hockey team, the Chicago Blackhawks. The Developer will enter into a five (5) year lease with the Chicago Blackhawks for an annual rental amount \$300,000.

The constructed building will be LEED-certified and contain a 50% green roof. Rain water retention and water collection are also planned on site. The building shall contain an entry lobby on West Madison Street dedicated to pedestrian access. The eastern portion of the site shall be dedicated to vehicular traffic and contain a turn-about driveway area. The north end of the driveway area will include an overhead door leading to underground parking that shall accommodate 63 parking spaces with handicapped parking slated to be placed adjacent to the main elevator.

The project will generate 21 on-site permane it (3 full-time and 18 part-time) jobs and 56 temporary construction jobs, subject to the City's resident employment requirements set forth in the Agreement.

The Developer has agreed, until the date the Redevelopme of Plan expires, to provide thirty (30) free Learn To Skate classes and free facility time to Chicago Pablic Schools teams each quarter throughout the school year to local residents and schools.
