## LEGAL DESCRIPTION

The estate or interest in the Land described below and covered herein is: The leasehold estate (said leasehold estate being defined in paragraph 1.C. Of the ALTA leasehold endorsement(s) attached hereto), created by the instrument herein referred to as the lease, executed by: Shakespeare Building Corporation, as lessor, and Evan Anderson and Catherine Anderson, as lessee, dated January 4, 1949, and assigned to Robert Allerton Cushman and Margaret Fleming Cushman April 24, 2013, which lease demises the following described land for a term of years beginning January 1, 1949 and ending December 31, 2047.

Apartment 3-H on the property commonly known as 2256 North Lincoln Park West in the apartment building collectively known as the "Building" situated at 312 Grant Place, 2236-58 Lincoln Park West and 311 Belden Avenue, Chicago located on the following Land (hereafter referred to as "Underlying Land")
