THIS INDENTURE, made this 21st day of February 1973, between FEDERAL SAVINGS AND LOAN INSURANCE CORPORATION, an agency of the United States Government, as Receiver for Apollo Savings Association, pursuant to an Order made by Justin Hulman, Commissioner of Savings and Loan Associations of Illinois, dated September 30, 1968, effective October 1, 1968, grantor, and ALAN G.
