TRUSTEE'S DEED

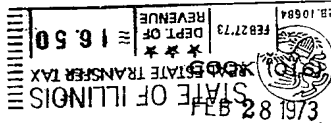

THIS INDENTURE, made this 27th day of February, 1973, between BEVERLY BANK, a banking corporation of Illinois, as successor Trustee, party of the first part, and MICHAEL A. HOSMAN, 9937 S. Prospect Avenue, Chicago, Illinois parties of the second part, WITNESSETH: WHEREAS, Old Beverly Bank (formerly Beverly Bank), a banking corporation of Illinois, was named Trustee under the provisions of a deed or deeds in trust duly recorded or registered and delivered to said Bank in pursuance of a trust agreement dated the 28th day of December, 1965, and known as Trust No. 8-0778; and WHEREAS, the aforesaid trust agreement was amended to provide that any corporate successor to the trust business of any corporate trustee named therein or acting thereunder shall become trustee in place of its predecessor without the necessity of any conveyance or transfer; and WHEREAS, said party of the first part succeeded to the trust business of said Old Beverly Bank on November 21, 1969 and is the duly authorized successor Trustee pursuant to said trust agreement as amended; NOW, THEREFORE, said party of the first part, in consideration of the sum of Ten Dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part,

the following described real estate, situated in Cook County, Illinois, to-wit:
lots 59 and 60 in Block 6 in Hough and Reed's addition to Washington Heights, Sub-
division of the South West 1/4 of Section 8, Township 37 North, Range 14 East of
the Third Principal Meridian, in Cook County, Illinois.

Together with the tenements and appurtenances thereunto belonging,
 TO HAVE AND TO HOLD the same unto said parties of the second part,
 and to the proper use, benefit and behoof forever of said party of the second part

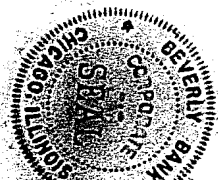
