- 3. **CAPITALIZATION AMOUNT.** I acknowledge that interest has accrued but has not been paid and the Lender also has incurred, paid or otherwise advanced taxes, insurance premiums and other expenses necessary to protect or enforce its interest in the Loan Documents and that such interest, costs and expenses, in the total amount of \$30,531.06, have been added to the principal balance owed under the Note and secured by the Security Instrument.
- 4. UNPAID PRINCIPAL BALANCE.
